- 1.2.1 The Average Annual Turnover of the B idder, should not be less than Rs. 142 Lakh s (Rupees One Crore Forty-two lakh only) d uring the preceding three (3) completed fin ancial years as on the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criter ia, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl.1.2.1 above, provided that the net wort h of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 1.2.3 In case the bidder is not able to furnish its audited fin ancial statements on stand-alone entity basis, the unaudit ed unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
- a. Copies of the unaudited unconsolidated financial statem ents of the bidder along with copies of the Audited

consolidated financial statements of its Holding Company.

- 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid op ening are not available, the financial results certified by a racticing Chartered Accountant shall be considered accept able.
