### 4. Instructions for filling the Price Bid:

- a. The total estimated value of Rs. 57,04,500/- (i.e. total of estimated value of Line 10) is exclusive of GST.
- b. The Bidder is required to quote Lumpsum Price (Including GST) in GeM Bid for BOQ item 10 against the total estimated value as mentioned at Point no. 1 above.
- c. The premium (%) or Discount (%) shall be derived considering total quoted amount excluding GST (as declared by bidder) w.r.t. estimated amount provided by NTPC against Line item 10.
- d. The derived premium (%) or Discount (%) against Line item 10 shall be uniformly applied on all the

BOQ items as mentioned in this Schedule of Quantities (BOQ) under Line item 10.

e. Bidder has to indicate GST (%) as applicable seven (7) days prior to last date of Bid Submission in the Attachment-9.

f. Quantity Mentioned "1" in Gem Bid for each item represents Lumpsum-price {i.e. {(Quantity x Unit Rate) + Quoted GST} for individual line item.

5. MSE Benefits are Applicable for this work. MSE bidders seeking exemption for EMD and Purchase Preference shall select appropriate option on GeM portal (separately for each i.e. EMD & purchase preference) and should enclose a attested/self-certified copy of UDYAM registration certificate, failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
