Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

7.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulat ed hereunder:

7.1 Technical Criteria:

7.1.1 (a) The bidder should be a manufacturer of Sodium Molybdate.

Proof of manufacturing shall be established through any of the following documents:

7.1.1 (a) (i) Valid factory license/ consent to operate from any Government statutory body such as Pollution Control Board/ NSIC registration/ any other valid document with mention o f any of the following terms:

7.1.1(b) The bidder should be an authorized representative of the above manufacturer(s). Authoris ed representative should be specifically authorized by the manufacturer to participate in this bid. I n case of award, authorised dealer has to supply material from the manufacturer only, along with supporting documents.

7.1.2 The bidder should have supplied Sodium Molybdate to any Govt. / semi-Govt. / PSU / Power s

ector / process industry in the last seven (07) years.

7.1.3. The bidder should have executed purchase orders for supply of chemicals during the precedi ng seven (07) years prior to the date of Techno-commercial bid opening, as per any of the fol lowing criteria:

1.One (1) order having executed value not less than Rs.358 Lakh.

OR

2.Two (2) orders each having executed value not less than $\ensuremath{\mathsf{Rs.224\,La}}$ $\ensuremath{\mathsf{kh}}$.

OR

3.Three (3) orders each having executed value not less than Rs.179 L akh.

Notes for 7.1

1.The word "Executed" mentioned above means that the bidder should ha ve achieved the criteria specified above, even if the total contract is starte d earlier and/or is not completed/closed.

2.In case of orders under execution, the quantity of work executed prior to the date of Techno-commercial bid opening duly certified by bidder's clien t shall be considered acceptable.

3.For arriving at the executed value of work specified at 7.1.2 above, basic amount only shall be considered. In case of contract is inclusive of ta xes, bidder should provide the break up of basic value and taxes.

7.2 Financial Criteria:

- **7.2.1** The Average Annual Turnover of the Bidder, should not be less than **Rs. 448 Lakh (Rupees four crore forty eight lakhs only)** during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 7.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 7.2.1 above on its o wn, its Holding Company would be required to meet the stipulated turnover requirements at Cl . 7.2.1 above, provided that the net worth of such Holding Company as on the last day of the p receding financial year is at least equal to or more than the paid-up share capital of the Holdin g Company. In such an event, the bidder would be required to furnish along with its Techno-Co

mmercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resoluti on, as per the format enclosed in the bid documents, pledging unconditional and irrevocable fi nancial support for the execution of the Contract by the bidder in case of award.

- **7.2.3** In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acce ptable provided the bidder further furnishes the following documents for substantiation of its q ualification.
 - Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial stat ements of its Holding Company.
 - A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaud ited unconsolidated financial statements form part of the Consoli dated Annual **Report of the company.**
- **7.2.4** In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Charter ed Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certific ate from practicing Chartered Accountant certifying its financial parameters, the audited resul ts of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial result s of the Company are under audit as on the date of Techno-Commercial bid opening and the C ertificate from the practicing Chartered Accountant certifying the financial parameters is not a vailable.

Notes for 7.2:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- 3. Net worth means the sum total of the paid-up share capital and free re serves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of th e revaluation of the assets, write back of depreciation provision and am algamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
