Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other

than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

#### 1. Scope of Supply

## **1.0 Qualifying Requirements:**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirement s stipulated hereunder:

## 1.1 Technical Criteria:

**1.1.1** The bidder should be a "Manufacturer of Backhoe Loader" or "Authorized Dealer/ Distributor/Channel Partner of Manufacturer" of **'Backhoe Loader'**.

**1.1.2** The bidder should have executed the order (s) for supply of "Backhoe loader" duri ng the preceding seven (07) years prior to date of Techno- commercial bid opening in any of the following manner:

(a) Executed value not less than Rs. 82 Lakhs in a Single Contract.

OR

(b) Executed value not less than Rs. 51 Lakhs in Two Contracts each.

OR

(c)Executed value not less than Rs. 41 Lakhs in Three Contracts each.

## Notes for Technical Criteria:

1. The word "Executed" mentioned above means that the bidder should have achie ved the criteria specified above, even if the total order is started earlier and/or is not comp leted/closed.

2. In case of orders under execution, the value of order executed prior to the date o f Techno-Commercial bid opening duly certified by bidder's client shall be considered acce ptable.

3. For arriving at the executed value of order specified above, basic amount only sh

all be considered. In case order is inclusive of taxes, bidder should provide the break – up of basic value and taxes.

4. Latest annual report OR NSIC / SSI / MSME registration certificate / BIS license / IS O certificate / MDCC/ any other statutory document as a proof of being manufacturer of th e required material.

## 1.2 Financial Criteria:

1.2.1 The Average Annual Turnover of the Bidder, should not be less than**103 lakhs** (**Rup ees One Crore Three Lakh**) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover require ments at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the I ast day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bi dder in case of award.

1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alo ne entity basis, the unaudited unconsolidated financial statements of the bidder can be co nsidered acceptable provided the bidder further furnishes the following documents for sub stantiation of its qualification.

(a)Copies of the unaudited unconsolidated financial statements of the bidder along with c opies of the Audited consolidated financial statements of its Holding Company.

(b)A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements for m part of the Consolidated Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practi cing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to su bmit the Certificate from practicing Chartered Accountant certifying its financial paramete rs, the audited results of three consecutive financial years preceding the last financial yea r shall be considered for evaluating the financial parameters. Further, a Certificate would b e required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Comme rcial bid opening and the Certificate from the practicing Chartered Accountant certifying th e financial parameters is not available.

## Notes for 1.2:

1 Other income shall not be considered for arriving at annual turnover.

2 "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.

3 Net worth means the sum total of the paid-up share capital and free reserves. Fr ee reserve means all reserves credited out of the profits and share premium account but d oes not include reserves credited out of the revaluation of the assets, write back of deprec iation provision and amalgamation. Further, any debit balance of Profit and Loss account a nd miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduc ed from reserves and surplus.

### Notes-

a. NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / inte nding bidder shall have any claim arising out of such action.

b. Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified.

d. Only PO submitted along with bid shall be considered for evaluation of Qualifying requirement.

e. Digitally TPIA/ISA certificate in format provided in ATC along with PO, Invoices, co mpletion certificate etc to be submitted.

f. Last three FY balance sheet with UDIN to be submitted along with bid.

g. Trader/authorized dealer are not exempted from EMD. They have to submit EMD In format attac hed in ATC.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
