#### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

**1. 1.** Bidder must submit the excel price breakup along with the PRICE BID only. The Techno-Commercial Bid

should not contain any price content entry. In case, the Techno-commercial Bid is found to contain any pric e content, such bid shall be rejected.

**2. 2.** The bidder has to fill the discount % in the column "M" & Local Transportation in column "O" of excel she et "BOQ for L1 evaluation".

**Note:** Bidder has to fill only the numeric value of % discount. It should not be suffixed by %. For example, if bidder wants to offer 90% discount on IATA rates, then entry in column "M" should be 90 & not 90%.)

**3.** The value as arrived in column "P32" after filling the rates in column "M" & "O" shall be filled by the bi dder in the GeM lumpsum price field & shall be considered as landed cost of bidder for evaluation purpose

Exchange rate considered in the excel sheet is TT selling rate as on 01.01.2024. However, actual contract I imiting price will be arrived by considering TT selling rate as on 7 days prior to actual techno-commercial b id opening date.

**4.** The e-PBG is kept as "No" in the GeM bid due to restriction of %. However, Contract Performance guara ntee shall be applicable as per clause 11 of SPC (Special Purchase Condition)

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
