- 3.0 All bids must be accompanied by Earnest Money Deposit for an amount calculated at the rate of **INR 11.60 Lakh per MW** (Indian Rupees Eleven Lakh Sixty Thousand per MW) and in the form as stipulated in the RfS Documents

**ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE EARNEST MONEY DEPOSIT IN A SEPARATE SEALED ENVELOPE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND RETURNED TO THE BIDDER WITHOUT BEING OPENED.**

4.0 **Qualifying Requirements for Bidders:**

Qualifying Requirements shall be as specified in the RfS documents.

- 5.0 NTPC reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.

- 6.0 Interested parties are required to get registered with M/s ISN Electronic Tender Services website <https://www.bharat-electronictender.com> (if not registered already).

The cost of the RfS documents as mentioned above is required to be submitted along with GSTIN and Organization ID registered with ETS portal or in the manner specified at 6.1 below. After registration, a complete set of RfS Documents may be downloaded by any interested Bidder from Portal <https://www.bharat-electronictender.com> with Tender Search Code **NTPC-2024-TN000001** free of cost. Interested parties are required to ensure that they have downloaded the official copy of RfS documents against Tender Search code- NTPC-2024-TN000001 from abovementioned website without which they will not be able to submit their bids. - 7.0 Issuance of RfS Documents to any Bidder shall not construe that such Bidder is considered to be qualified. Bids shall be submitted online. Bidder shall furnish Earnest Money Deposited, Integrity Pact, Pass Phrase and Board Resolution separately offline as detailed in RfS Documents before the stipulated bid submission closing date and time at the address given below.
- 8.0 Transfer of RfS Documents purchased by one intending Bidder to another is not permissible.
- 9.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects
