- 7.0 Issuance of RfS Documents to any Bidder shall not construe that such Bidder is considered to be qualified. Bids shall be submitted online. Bidder shall furnish Earnest Money Deposit, Integrity Pact, Pass Phrase and Board Resolution separately offline as detailed in RfS Documents before the stipulated bid submission closing date and time at the address given below.
- 8.0 Transfer of RfS Documents purchased by one intending Bidder to another is not permissible
- 9.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects
