1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Certificates

3.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

1.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

1.1 Technical Criteria:

1.1.1 The bidder should have executed order(s) of 'valves and/or valve spares' for 'vacuum conveying dry ash handling system' within preceding seven (07) years prior to date of Techno-commercial bid opening.

1.1.2 The bidder should have executed order(s) for 'Supply of spares for ash handling system for any coal based thermal power plant', within preceding seven (07) years prior to date of Techno-commercial bid opening in any of the following manner :
