**1.0 QUALIFYING REQUIREMENT (OR)**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

## 1.1 TECHNICAL CRITERIA

1.1.1 The bidder should be a manufacturer of CT of 220 kV Voltage class or above.

1.1.2 The Bidder should have executed order(s) for supply of Instrument transformers including CTs of 220 KV or above voltage class within preceding 07 (seven) years as on the date of Techno-commercial bid opening in any of the following manner:

(a) Single order with executed value not less than **Rs. 88 Lakhs**

OR

(b) Two orders with executed value not less than **Rs. 55 Lakhs each**

### Notes for Technical Criteria:

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
2. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break - up of basic value and taxes.
3. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.

## 1.2 Financial Criteria:

1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 110 Lakh (Rupees One Hundred & Ten Lakh only)** during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of t

he Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
