Bidders are bound to accept the orders accordingly.

Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the biddin g documents, stating that the unaudited unconsolidated financial statements form part of the Cons olidated Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of techno-c ommercial bid opening are not available, the financial results certified by a practicing Chartered Ac countant shall be considered acceptable.
