Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of guoted prices which would be determined by the buyer based on its own assessment of reasonableness and

#### 1.0 BRIEF SCOPE OF WORK

The scope of supply includes Consolidated **Procurement of Segregating Valve Spares for NTPC Stati** ons

### QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidders who wish to participate in the bidding shall satisfactorily meet the Qualifying

### 1.1. Technical Criteria:

1.1.1 The bidder should have executed order(s) for supply of 'valves and/or valve spares' for 'vacuum con veying dry ash handling system' within preceding seven (07) years prior to date of Techno- commercial bi d opening.

1.1.2 The bidder should have executed order(s) for 'Supply of spares for ash handling system for any coal based thermal power plant', within preceding seven (07) years prior to date of Techno- commercial bid op ening in any of the following manner:

(a) One (1) order having executed value not less than Rs. 89 Lakh

### OR

(b) Two (2) orders having executed value not less than Rs. 56 Lakh each

### OR

(c) Three (3) orders having executed value not less than **Rs 45 Lakh** each.

### Notes for Technical Criteria:

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.

- 3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 4. **'Valves and/or valve spares' for 'vacuum conveying dry ash handling system'** means segregating valves (or branch isolating valves) and/or material handling valve (or ash intake valves) and/or dome valve and/or any other 'valve or valve spares' for vacuum conveying ash handling system.

### 1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 112 Lakh (Rupees One C rore Twelve lakh only)** during the preceding three (3) completed financial years as on the date of T echno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its H olding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, p rovided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, t he bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking f rom the Holding Company, supported by Board Resolution, as per the format enclosed in the bid docu ments, pledging unconditional and irrevocable financial support for the execution of the Contract by th e bidder in case of award.
- 1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, t he unaudited unconsolidated financial statements of the bidder can be considered acceptable provide d the bidder further furnishes the following documents for substantiation of its qualification.
- (a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- (b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding docume nts, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual R eport of the company.
  - 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commer cial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Ch artered Accountant certifying its financial parameters, the audited results of three consecutive financia al years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding d ocuments stating that the Financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the fi nancial parameters is not available.

#### Notes for 1.2:

- (a) Other income shall not be considered for arriving at annual turnover.
- (b) "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companie s Act of India, in vogue.
- (c) Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balan ce of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

Other Terms and conditions shall be applicable as per Gem GTC.

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. - 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
