1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

1.0 QUALIFYING REQUIREMENT :

7.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipula ted hereunder:

7.1.0 Technical Criteria:

7.1.1 a) The bidder should be a manufacturer of Benchtop Energy Dispersive X-Ray Analyzer (ED X RF).

OR

b) An authorized dealer / distributor / channel partner / Indian representative of the manufac turer of Benchtop Energy Dispersive X-Ray Analyzer (ED XRF). Authorized representative sh ould be specifically authorized by the manufacturer to participate in this bid.

- 7.1.2 The bidder should have executed purchase orders for supply of Laboratory Analysis Instrume nts including PC controlled Benchtop Energy Dispersive X-Ray Analyzer (ED XRF) as one of t he items within preceding seven (07) years Prior to the date of Techno-commercial bid openi ng as per any of the following criteria:
 - a) One (1) order having executed value not less than Rs.54 Lakh.

Or

b) Two (2) orders having executed value not less than Rs 34 Lakh each.

Or

c) Three (3) orders having executed value not less than Rs 27 Lakh each.

Notes for Clause 7.1.2:

Note-1: The word "executed" means the bidder should have achieved the criterion specified in the QR, even if the total order(s) is not completed/closed. In case of order(s) under execution as on the date of techno commercial bid opening, the value of work executed till such date will be considere d provided the employer certifies the same.

Note-2: For the purpose of arriving at the executed value of work, basic amount only shall be cons idered. In case of order(s) inclusive of taxes, agency has to provide the break -up of basic value an d taxes.

Note-3: The authorized dealer / distributor / channel partner / Indian representative of the manufa cturer having tender Specific authorization from the manufacturer who meets the Qualifying Requir ements stipulated in criteria 7.1.1. can furnish their own documents or documents of manufacturer / principal against QR criteria 7.1.2 as documentary proof for qualifying requirement.

7.2.0 Financial Criteria

7.2.1 Average annual Turnover of the bidder in the preceding three (3) financial years as on the dat e of Techno-Commercial bid opening, shall not be less than **Rs 67 Lakhs (Rupees sixty seven la khs only).**

7.2.2 In case a bidder does not satisfy the financial criteria, stipulated at Cl. 7.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 7.2.1 a bove, provided that the Net Worth of such Holding Company as on the last day of the preceding fin ancial year is at least equal to or more than the paid-up share capital of the Holding Company. In s uch an event, the Bidder would be requested to furnish along with its Techno-Commercial bid, a Let ter of Undertaking from the Holding Company, supported by the Holding Company's Board Resoluti on, as per the format enclosed in the Bid Documents, pledging unconditional & irrevocable financial support for the execution of the Contract by the Bidder in case of award

7.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptabl e provided the bidder further furnishes the following documents for substantiation of its qualificatio n.

- Copies of the unaudited unconsolidated financial statements of the bidder along with copie s of the Audited consolidated financial statements of its Holding Company.
- A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form pa rt of the Consolidated Annual Report of the company.

7.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-C ommercial bid opening are not available, the financial results certified by a practicing Chartered Ac countant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from p racticing Chartered Accountant certifying its financial parameters, the audited results of three cons ecutive financial years preceding the last financial year shall be considered for evaluating the finan cial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclo sed in the bidding documents stating that the Financial results of the Company are under audit as o n the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Acc ountant certifying the financial parameters is not available.

Notes for 7.2.0:

- 1. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.
- 2. Other income shall not be considered for arriving at annual turnover.

3. Net worth means the sum total of the paid-up share capital and free reserves. Fr ee reserve means all reserves credited out of the profits and share premium acco unt but does not include reserves credited out of the revaluation of the asse ts, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from res erves and surplus

2.0 MANDATORY DOCUMENTS :

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
