- 4.1.2 The bidder should have executed contract for supply of Transformer of voltage rating 11KV or above as per the following during the preceding seven (07) years as on the dat e of techno-commercial bid opening:
 - (i) Single contract with Executed value not less than Rs 225 lakhs.

OR

(ii) Two (02) contracts with Executed value not less than Rs 141 Lakhs Each

OR

(iii) Three (03) contracts with Executed value not less than Rs 112 Lakhs each.

Notes for 4.1:

- The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed / closed.
- In case of orders under execution, the value of work executed prior to the date

4.2 Financial Criteria:

- The Average Annual Turnover of the Bidder, should not be less than **Rs. 281 Lakhs** (**Rupees Two crore and eighty -one lakhs only)** during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 4.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 4.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover required tements at Cl. 4.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid docume nts, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 4.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone e ntity basis, the unaudited unconsolidated financial statements of the bidder can be consi dered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
