1. Buyer Added Bid Specific ATC

1.0 **QUALIFYING REQUIREMENTS FOR BIDDERS.**

The bidder who wishes to participate in the bidding shall meet the Qualifying Require ments stipulated hereunder:

1.1 Technical Criteria:

1.1.1 The bidder should have executed the work of providing hiring services for Farana Crane(s) of 15 Ton or higher capacity within preceding seven (07) years prior to the date of techno – commercial bid opening

1.1.2 The bidder should have executed the work of **Supply of Cranes on 'Hire/Lea se' basis within preceding seven (07) years prior to the date** of Techno-Com mercial bid opening, in any of the following manner

A. One (1) order having executed value not less than Rs. 45 Lakh

OR

B. Two (2) orders having executed value not less than Rs. 28 Lakh each

OR

C. Three (3) orders having executed value not less than Rs. 23 Lakh each

Notes for Technical Criteria:

1. The word "Executed" mentioned above means that the bidder should have achiev ed the

criteria specified above, even if the total contract is started earlier and/or is not comp leted/closed. 2. In case of orders under execution, the value of work executed prior to the date of Techno-

Commercial bid opening duly certified by bidder's client shall be considered accepta ble.

3. For arriving at the executed value of work specified above, basic amount only shall be

considered. In case contract is inclusive of taxes, bidder should provide the break – u p of basic value and taxes.

4. For arriving at the executed value of work specified above, basic amount only shall be considered . In case of contract is inclusive of reimbursable fuel charges than reim bursable fuel charges will not be considered for arriving at executed value . The bidd er should provide the break –up of basic value & reimbursable fuel charges.

1.2 Financial Criteria:

1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 57 La kh (Rupees Fifty Seven lakh only) during the preceding three (3) completed financ**ial years as on the date of Techno-Commercial bid opening.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 a bove on its own, its Holding Company would be required to meet the stipulated turno ver requirements at Cl.

1.2.1 above, provided that the net worth of such Holding Company as on the last day of the

preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish alon g with its Techno- Commercial bid, a Letter of Undertaking from the Holding Compan y, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Cont ract by the bidder in case of award.

1.2.3 In case the bidder is not able to furnish its audited financial statements on stan d-alone

entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

(a)Copies of the unaudited unconsolidated financial statements of the bidder along wi th

copies of the Audited consolidated financial statements of its Holding Company.

(b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclos ed in

the bidding documents, stating that the unaudited unconsolidated financial statemen ts form part of the Consolidated Annual Report of the company

1.2.4 In cases where audited results for the last preceding financial year as on the da te of $% \left({{{\left[{{T_{{\rm{s}}} \right]}} \right]}_{\rm{s}}}} \right)$

Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is no t able to submit the Certificate from practicing Chartered Accountant certifying its fin ancial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Fur ther, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under au dit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 1.2:

i. Other income shall not be considered for arriving at annual turnover.

ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to

them as per Companies Act of India, in vogue.

iii. Net worth means the sum total of the paid-up share capital and free reserves. Fre $\ensuremath{\mathsf{e}}$

reserve means all reserves credited out of the profits and share premium account bu t does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Lo ss account and miscellaneous expenses to the extent not adjusted or written off, if a ny, shall be reduced from reserves and surplus.

- 4.0 List of documents mentioned in ATC To be uploaded online duly filled in .
- 5.0 Other documents in support of QR.

6.0 The shortfall information / documents should be sought only in case of histo rical documents which pre-existed at the time of the tender opening and which have not undergone change since then. So far as the submission of documents i s concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. For exam ple, if the bidder has submitted a supply order without its completion / performa nce certificate, the certificate can be asked for and considered. However, no ne w work order should be asked for so as to qualify the bidder

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
