4. **Qualifying Requirements for Bidders**:

The bidders who wish to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

4.1 **Technical Criteria:**

4.1.1 The bidder should be a manufacturer/OEM of Personal Computers (PC)/Laptop computers/All-In-One (AIO) Computers / Servers having facility in India for manufacture of PCs/Laptops/AIO/Servers.

OR

The bidder should be subsidiary/dealer/channel partner of the manufacturer/OEM as above as on the date of opening of techno-commercial bid. Such bidder should be duly authorized by the manufacturer/ OEM as above for this tender.

4.1.2 The bidder should have executed work(s) for supply of PCs/laptop computers/ AIO computers/Servers/Workstations for any NTPC station/SEB/Govt. Semi-Govt. agency/PSUs/ Educational Institute/NSE or BSE enlisted company in India, within preceding 07 (seven) years prior to the date of Techno-commercial bid opening in any of the following manner:

(i) Executed value not less than Rs 117 Lakhs in a single contract.

OR

ii) Executed value not less than Rs 73 Lakhs each in two contracts.

OR

(iii) Executed value not less than Rs 58 Lakhs each in three contracts.

Notes for 4.1.2:

- 1. The word "Executed" mentioned above means that the bidder should have achi eved the criteria specified above, even if the total contract is started earlier and/ or is not completed / closed.
- 2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be consi dered acceptable.
- 3. For arriving at the executed value of work specified above, basic amount only s hall be considered. In case of contract is inclusive of taxes, bidder should provide the break –up of basic value and taxes.

4.2 Financial Criteria:

- 4.2.1 The average annual turnover of the bidder, in the preceding three (3) financial years a s on the date of Techno-Commercial bid opening, shall not be less than **Rs. 146 Lakhs** (**Rs One Hundred Forty Six Lakhs Only**).
- 4.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 4.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 4.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 4.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone e ntity basis, the unaudited unconsolidated financial statements of the bidder can be consi dered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:
 - 1. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.
 - 2. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statement s form part of the Consolidated Annual Report of the company.
- 4.2.4 In cases where audited results for the last financial year as on the date of techno comme rcial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno comme rcial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascr ibed to them as per Companies Act of India, in vogue.
- 3. **Net worth means** the sum total of the paid-up share capital and free reserves. F ree reserve means all reserves credited out of the profits and share premium acco

unt but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

- Notwithstanding anything stated above, the Employer reserves the right to assess the ca
 pabilities and capacity of the Bidder/ his collaborators /associates/ subsidiaries / group co
 mpanies to perform the contract, should the circumstances warrant such assessment in t
 he overall interest of the Employer. The physical assessment shall include but not be limit
 ed to the assessment of office/facilities/banker's/reference workers by Employer. A negati
 ve determination of such assessment of capacity and capabilities may result in rejection
 of the bid.

Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Acc ount (wherever applicable) undertaken/ signed by a Member of Institute of Char tered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).

- 3. This is a NO DEVIATION TENDER, which means- no deviation, whatsoever, is permitted by the employer to any provisions of bidding documents.
- 4. Any 'Bidder from a country which shares a land border with India', as specified in the Bid ding Documents, will be eligible to bid in this tender only if bidder is registered with the C ompetent Authority as mentioned in the Bidding Documents.
