## **BUYER ADDED ADDITIONAL TERMS & CONTIONS (ATC)**

## I. TERMS & CONDITIONS:

- 1. **Delivery/ Completion Period:** Within 240 days from PO
  - Vendor has to supply grinding balls and ring in sets:
     01 set = 10 No grinding balls+ 01 Filler Ball + top ring + bottom ring
  - Lead time to start the delivery after placement of PO shall be 90 Days Max.
  - Thereafter, Vendor has to supply 02 sets every month.
  - Complete the delivery within 08 months from date of PO.

(03 Months Lead time) + (10/02 = 5 Months) = 08 Months (240 days)

- 2. **Inspection:** Pre dispatch inspection (PDI) shall be carried out by NTPC RIO at the works of vendor as per technical specification, standard quality plan. Vendor has to accept the NTPC standard quality plan. Materials are to be dispatched only after issue of MDCC from NTPC.
- 3. **Payment Term:** 100% payment within 10 days of Consignee's Receipt & Acceptance Certificate (CRAC) Generation in GeM.
- 4. **WARRANTY / GUARANTEE:** The grinding balls and rings shall be guaranteed as a set consisting of 10 no. of hollow grinding balls, 1 no. hollow filler ball, top ring and bottom ring for a minimum wear life of 4500 running hours per set. Details as per Technical Specifications.
- 5. **PBG (Performance bank Guarantee):** PBG for an amount equal to **5%** of total order value of GeM Contract to be submitted within 30 days of placement of award. PBG should initially be valid for a period of 24 months and should be suitably extended to cover the guarantee period of 4500 running hours for all the sets.

## II. ELIGIBILITY FOR PARTICIATION IN TENDER:

'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

## The minimum local content shall be 60%.

## III. QUALIFYING REQUIREMENT

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

## 1.1 Technical Criteria:

1.1.1 The Bidder should have been a regular manufacturer of E-type coal pulverisers and should have supplied such coal pulverisers to at least 2 coal fired units, each of 200MW or higher capacity and which are in successful operation prior to the date of Techno-Commercial bid opening.

## **OR**

1.1.2 (a) The bidder should have been a manufacturer of "Ni hard / Hi chrome" castings with inhouse casting facilities with minimum annual manufacturing capacity of 90 MT and should have supplied at least {three Set of Grinding "Balls & Rings" ( Grinding Ring of Diameter 85 inches or more) OR "30 No's of Grinding Balls & 6 No's of Grinding Rings(Top/Bottom) having Grinding Ring Diameter 85 inches or more"} of "Ni Hard and/or Hi chrome" material used in Coal pulverisers during last seven (07) years prior to the date of techno-commercial bid opening.

## **AND**

1.1.2 (b) The bidder should either himself or through a Company/Agency in which he has controlling stake, own following manufacturing and testing facilities for use by the bidder for manufacturing of the grinding balls. (Bidder to furnish proof of ownership/controlling stake of the facilities along with his bid).

## **Manufacturing Facilities:**

- a) Induction / Cupola / Induction Arc Furnace (Single/Multiple) for melting iron 8.0 (Eight) Tones at a time.
- b) Machining facilities for machining grinding rings
- c) Heat treatment facility for grinding balls

## **Testing Facilities:**

- a) Hardness testing
- b) Micro structure testing
- c) Chemical composition testing
- d) Ultrasonic testing machine
- e) Spectrometer/Spectrogram

- 1.1.3 The bidder should be a manufacturer of "Grinding Ball(s) & Ring(s)" of "Ni Hard / Hi Chrome" material for Coal pulverisers and should have supplied at least {two Set of Grinding "Balls & Rings" ( Grinding Ring of Diameter 85 inches or more) OR "20 No's of Grinding Balls & 4 No's of Grinding Rings (Top/Bottom) having Grinding Ring Diameter 85 inches or more"} for coal pulverisers and should have an "ongoing collaboration / license agreement" with a manufacturer who meets the qualifying requirements as stipulated at Clause 1.1.2 (a) above. In such a case, bidder along with his collaborator shall furnish a Deed of Joint Undertaking (DJU) as per the format enclosed in the Bid documents for successful performance of the grinding rings offered by him. The joint deed(s) of undertaking shall be submitted along with the bid, failing which the bidder shall be disqualified and his bid shall be rejected. In case of award, the collaborator will be required to furnish on demand bank Guarantee for 1.5% of the total contract price in addition to the Contract Performance Securities to be furnished by the bidder. Further Bidder should have manufacturing and testing facilities as per 1.1.2(b) above.
- 1.1.4 The Bidder should have successfully executed supply of "E-type Coal pulverisers / Grinding elements for Coal pulverisers" within preceding seven (07) years prior to the date of Techno-Commercial bid opening, in any of the following manner:
  - A. One (1) order having executed value not less than Rs. 379.0 Lakh

OR

**B.** Two (2) orders having executed value not less than **Rs. 237.0 Lakh** each

OR

C. Three (3) orders having executed value not less than Rs. 190.0 Lakh each

## **Notes for Technical Criteria:**

- The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. 1 SET of Grinding (Balls & Rings) consists of 10 Nos's of Grinding Balls & 02 No's of Rings (Top & Bottom).

- 3. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 4. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break –up of basic value and taxes.

#### 1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than Rs. 474 Lakh (Rupees Four Hundred & Seventy Four lakh only) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
  - Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
  - A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

Notice or invocation by any person such as assignee, transferee of agent of beneficiary shall not be entertained by the bank. Any invocation of guarantee can be made only by the beneficiary directly.

The inclusion of the aforesaid clause in the BGs restricts the rights of NTPC under the BG and it may not be possible for NTPC to accept the aforesaid clause in the BGs submitted to us by our Bidders. It may also be mentioned that incorporation of the above additional clause in the BG results in the BG being returned by NTPC and consequently rejection of the bids of parties that have submitted such BGs.

In view of the above, it is requested that please take up at appropriate levels so that suitable instructions are issued to all your branches not to incorporate any such additional clause and henceforth BGs may be issued strictly as per NTPC format only.
