If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

2. 3. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

**1. Buyer Added Bid Specific ATC**

**1.0 QUALIFYING REQUIREMENTS FOR BIDDERS.**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

**1.0 Technical Criteria:**

1.1. The bidder should have executed order which includes 'erection/ maintenance' work of metallic pipelines of minimum length 2 Kilometres, diameter 200NB or more in a single work order within preceding 07 (seven) years prior to the date of Techno- commercial bid opening in any of the following manner:

**A. One (1) order having executed value not less than Rs. 140 Lakh**

OR

**B. Two (2) orders having executed value not less than Rs. 88 Lakh each**

OR

**C. Three (3) orders having executed value not less than Rs. 70 Lakh each**

**Notes for Technical Criteria:1.0**

1. The word "Executed" mentioned above means that the bidder should have achieved the

criteria specified above, even if the total contract is started earlier and/or is not completed/closed.

2. Execution of following jobs in isolation shall not be treated as credential for subject

- works: (i) Execution of Structural Fabrication only  
(ii) Civil Pedestal jobs for laying of pipelines only  
(iii) Pipeline rotation job only...

3. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the subcontractor in support of qualifying requirements.

4. Reference works executed by the bidder, as a member of joint Venture / Consortium / Associate can also be considered provided

a) The allocation of scope of work between the partners of the joint Ventures / consortium / Associate is clearly defined in the executed joint venture agreement / consortium agreement / deed of joint undertaking and the bidder's scope of work and break-up of quantities executed by them as individual contribution in the joint Venture / Consortium /

Associate, duly authenticated by the Project Authority/Owner, meet the relevant provisions of eligibility criteria.

b) In case the reference work has been executed by the bidder in an integrated joint venture wherein allocation of scope of work and break-up of quantities between the partners is not clearly specified in the integrated joint venture Agreement, then for establishing the eligibility as per technical criteria 1.1 of QR, the credit of executed quantities can be claimed by the bidder in the ratio of bidder's share in the integrated joint Venture Agreement, provided the applicant establishes that it regularly undertakes works mentioned in QR. The executed works/ quantities by the integrated joint venture shall be duly authenticated by the Project

Authority/owner.

## 2.0 Financial Criteria:

2.1 The Average Annual Turnover of the Bidder, should not be less than **176 Lakhs (Rupees One Crore Seventy Six Lakhs only) during the preceding three (3) completed financial** years as on the date of Techno-Commercial bid opening.

2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. .2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl..2.1 above, provided that the net worth of such Holding Company as on the last day of the

preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along

g with its Techno- Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone

entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

(a) Copies of the unaudited unconsolidated financial statements of the bidder along with

copies of the Audited consolidated financial statements of its Holding Company.

(b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in

the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

2.4 In cases where audited results for the last preceding financial year as on the date of

Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 2.0:

i. Other income shall not be considered for arriving at annual turnover.

ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.

iii. Net worth means the sum total of the paid-up share capital and free reserves. Free

reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

**DOCUMENTS TO BE SUBMITTED BY THE BIDDER WITH THE BID:**

Legible copies of the following documents duly authenticated by the authorized **TPIA (Third party inspection agency)** or **ISA** (independent statutory auditor) shall be submitted in support of the qualifying requirements along with technical bid:

1.0 **Relevant Order copies along with Proof of Execution** (completion certificate etc) certified by **TPIA or ISA** .(Format attached in section VII **Forms and procedure** )

- 2.0 Soft copy of Micro & Small Enterprise (MSE) certificate ( **Udyam Registration Certificate**).
- 3.0 **Copy of Profit & Loss Account & Balance Sheet** for the preceding three (03) completed financial years as on date of bid opening. **With UDIN.**
- 4.0 **List of documents mentioned in ATC** To be uploaded online duly filled in .
- 5.0 Other documents in support of QR.

6.0 For arriving at the executed value of work specified in QR, basic amount only shall be

considered. In case the contract is inclusive of taxes, bidder should provide the break- up of basic value and taxes.

7.0 The shortfall information / documents should be sought only in case of **historical documents** which pre-existed at the time of the tender opening and which have not undergone change since then. So far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. For example, if the bidder has submitted a supply order without its completion / performance certificate, the certificate can be asked for and considered. **However, no new work order should be asked for so as to qualify the bidder**

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
