## 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1.0 Technical Criteria:
- 1.1 The bidder should have executed work for "Deployment and operation of Pumps" with minim um cumulative flow capacity of 500m3/hr in a single Contract within the preceding seven (07) ye ars prior to the date of Techno-Commercial bid opening.
- 1.2 The bidder should have executed the work(s) of "Deployment and Operation of Pumps" within preceding seven (07) years prior to the date of Techno- Commercial bid opening, in any of the following manner:
- One (1) order having executed value not less than Rs. 88 Lakh OR
- Two (2) orders having executed value not less than Rs. 55 Lakh each OR
- Three (3) orders having executed value not less than Rs. 44 Lakh each

Notes for Technical Criteria:

1.0 The word "Executed" mentioned above means that the bidder should have achi eved the criteria specified above, even if the total contract is started earlier and/or i

s not completed/closed.

- 2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 3. Reference work executed by the bidder as a sub-contractor may also be consider ed provided the certificate issued by main contractor is duly certified by owner spec ifying the scope of work executed by the sub-contractor in support of qualifying requirements.
- 4. Meaning of word "Deployment" shall be construed as both Supply and Installatio
- 5. Total order value shall be considered for execution capability calculation purpose
- 6. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
  - 2.0 Financial Criteria:
- 2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs 109 Lakhs** (Rupees O ne Crore Nine Lakhs only) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 6.2.1 above on its own , its Holding Company would be required to meet the stipulated turnover requirements at Cl. 6 .2.1 above, provided that the net worth of such Holding Company as on the last day of the prec eding financial year is at least equal to or more than the paid-up share capital of the Holding C ompany. In such an event, the bidder would be required to furnish along with its Techno- Com mercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolutio n, as per the format enclosed in the bid documents, pledging unconditional and irrevocable fin ancial support for the execution of the Contract by the bidder in case of award.
- 2.3 In case the bidder is not able to furnish its audited financial statements on stand- alone entity basis, t he unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
  - a) Copies of the unaudited unconsolidated financial statements of the bidder along with copie s of the Audited consolidated financial statements of its Holding Company.
  - b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
  - 2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Co mmercial bid opening are not available, the financial results certified by a practicing Chartered Acc ountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from p racticing Chartered Accountant certifying its financial parameters, the audited results of three cons ecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclo sed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 2.0:

- i. Other income shall not be considered for arriving at annual turnover.
- ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as pe r Companies Act of India, in voque.

Net worth means the sum total of the paid-up share capital and free reserves. Free r eserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Lo ss account and miscellaneous expenses to the extent not adjusted or written off, if a ny, shall be reduced from reserves and surplus .

6.0 The shortfall information / documents should be sought only in case of historical documents which preexisted at the time of the tender opening and which have not undergone change since then. So far as the s ubmission of documents is concerned with regard to qualification criteria, after submission of the tender, o nly related shortfall documents should be asked for and considered. For example, if the bidder has submitt ed a supply order without its completion / performance certificate, the certificate can be asked for and con sidered. However, no new work order should be asked for so as to qualify the bidder

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्तें, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
