- 2. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

## 1.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidder who wishes to participate in the bidding shall meet the Qualifying Require ments stipulated hereunder

#### 1.0 Technical Criteria:

1.1 (a) The bidder should have erected and commissioned Ash Handling System with D ry Fly ash evacuation system for one (01) Coal based power plant of minimum 1000 MW capacity with unit size 200 MW or above within preceding 07 (seven) years prior to the date of Techno-commercial bid opening.

## OR

- 1.1(b) The bidder should have executed the works of Operation and Maintenance of As h Handling System with Dry Fly ash evacuation system, in one (01) Coal based powe r plant of minimum 1000 MW capacity with unit size 200 MW or above in India for a minimum period of one (01) year in a single contract within preceding 07 (seven) years prior to the date of Techno-commercial bid opening.:
- **1.1.2** The Bidder should have executed the Contract as per Clause 1.1 (a) or 1.1 (b) above, within preceding seven (07) years prior to the date of Techno-Commercial bid opening, in any of the following manner:

- a. One (1) order having executed value not less than **Rs. 82 lakh**OR
- Two(2) orders having executed value not less than Rs. 51 lakh each
   OR
- c. Three(3) orders having executed value not less than Rs. 41 lakh each

#### Notes for Clause 1.0 above:

- 1. The word "erected and commissioned" mentioned at 1.1(a), means that the bidder should have ere cted and commissioned the work of Ash handling system with Dry Fly ash evacuation system, as per c apacity and rating size mentioned above, within the preceding 07 (seven) years prior to the date of Te chno-commercial bid opening even if it is done against a contract which has been started earlier or is in continuation and not yet closed. Similarly, the word 'executed" mentioned at 1.1(b), means that the said execution of specified duration in a power plant of specified capacity and rating, must have been executed within the preceding Seven years (07) prior to the date of Techno-commercial bid opening e ven if it is done against a contract which has been started earlier or is in continuation and not yet closed.
- 2. Reference work executed by the bidder as a sub-contractor may also be

considered provided that the certificate issued by the main contractor is duly certified by owner specif ying the scope of work executed by the subcontractor

in support of qualifying requirements.

- 3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 4. In case of orders under execution, the value of work executed prior to the

date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptabl e.

- 5. Reference works executed by the bidder, as a member of joint Venture / Consortium / Associate can also be considered provided:
- a) The allocation of scope of work between the partners of the joint Ventures / consortium / Associate is clearly defined in the executed joint venture agreement / consortium agreement / deed of joint und ertaking and the bidder's scope of work and break-up of quantities executed by them as individual contribution in the joint Venture / Consortium / Associate, duly authenticated by the Project Authority/Owner, meet the relevant provisions of eligibility criteria.
- b) In case the reference work has been executed by the bidder in an integrated joint venture wherein allocation of scope of work and break-up of quantities between the partners is not clearly specified in the integrated joint venture Agreement, then for establishing the eligibility as per technical criteria 1.1 of QR, the credit of executed quantities can be claimed by the bidder in the ratio of bidder's share in t

he integrated joint Venture Agreement, provided the applicant establishes that it regularly undertakes works mentioned in QR. The executed works/ quantities by the integrated joint venture shall be duly a uthenticated by the Project Authority/owner."

#### 2.0 Financial Criteria:

2.1 The Average Annual Turnover of the Bidder should not be less than Rs. 103

**Lakhs (Rupees One Hundred Three Lakhs only)** during the preceding three (3) completed financial ye ars prior to the date of Techno-Commercial bid opening.

- 2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl..2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
  - (a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
  - (b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Fur ther, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding doc uments stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

## Notes for 2.0:

i. Other income shall not be considered for arriving at annual turnover.

ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in voque.

Net worth means the sum total of the paid-up share capital and free reserves. F ree reserve means all reserves credited out of the profits and share premium ac count but does not include reserves credited out of the revaluation of the assets , write back of depreciation provision and amalgamation. Further, any debit bala nce of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

- 3.0 **Copy of Profit & Loss Account & Balance Sheet** for the preceding three (03) c ompleted financial years as on date of bid opening. **With UDIN.**
- 4.0 List of documents mentioned in ATC To be uploaded online duly filled in .
- 5.0 Other documents in support of QR.

The shortfall information / documents should be sought only in case of historical documents which pre-existed at the time of the tender opening and which have not undergone change since then. So far as the submission of documents is con cerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. For example, if the bidder has submitted a supply order without its completion / performance c ertificate, the certificate can be asked for and considered. However, no new work order should be asked for so as to qualify the bidder.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
