4. Qualifying Requirements for Bidders:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

4.1 **Technical Criteria:**

4.1.1 Route-1 [Meeting Criterion 4.1.1 (a) & 4.1.1 (b)]

4.1.1 (a) Proven Experience

The Bidder should be the 'Original Equipment Manufacturer (OEM) of Siemens make Gas Turbine or its equivalent design' OR 'manufacturer of Siemens make Gas Turbine Blades or its equivalent design'.

Further, the Bidder must have supplied at-least two (2) Sets of Gas Turbine/Gas Turbine Ro tor/ 'Gas Turbine Blades/Vanes (Out of two sets minimum one set should be Blades) of any stage' for Siemens make Gas Turbine or its equivalent design of minimum 100 MW ISO rating, which should have completed successful operation of at least "one Hot Gas Path Inspection (HGPI) or major overhaul" having minimum 15,000 Equivalent Overhauling Hours (EOH) prior to the techno-commercial bid opening date.

4.1.1 (b) Specific Plant related Technology and capability

Bidder must either himself possess or have access to the necessary technology for manufa cturing Blades of Siemens make Gas Turbine Model No. V 94.2 or its equivalent design applicable for Dadri Gas Power Station having ISO rating of 142.42 MW at Turbine Inlet Temp (T IT) of 1060 Deg C.

The Bidder at his option can also outsource any of the activities required for manufacturing of the above blades subject to the condition that the chosen outsource agency by the bidder also has the necessary technology for manufacturing of Blades of Siemens make Gas Turbine Model No. V 94.2 or its equivalent design applicable for Dadri Gas Power Station having ISO rating of 142.42 MW at Turbine Inlet Temp (TIT) of 1060 Deg C.

4.1.2 **Route-2**

The Bidder can be licensee or Authorized Agent of Gas Turbine original equipment manuf acturer (OEM) or its equivalent design. In such case, the bidder can be considered qualified based on the experience of the Principal who meets the requirements mentioned at para 4.1.1 (a) and 4.1.1 (b) above.

Notes for 4.1.1 & 4.1.2

NTPC has the right to access the capability and capacity of the bidder for carrying out the manuf acturing of required Gas Blades of V 94.2 machines of its Dadri plant, in case of bidder meets the above qualifying requirement through any route

4.2 Financial Criteria:

- 4.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 19.78 Cr (Rupee s Nineteen Crores Seventy-Eight lakhs only)** during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 4.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 4.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 4.2.1 above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in ca

se of award.

4.2.3 The Net Worth of the bidder shall not be less than 100% of the bidder's paid up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net Worth based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of its holding companies wherever applicable, the Net Worth of the Bidder and its Subsidiary(ies) and/or Holding Company and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of their total paid up share capital. However individually, their Net worth should not be less than 75% of their respective paid-up share capitals.

Net worth in combined manner shall be calculated as follows:

Where X1, X2, X3 are individual Net worth which should not be less than 75% of their respective paid-up share capitals and Y1, Y2, Y3 are individual paid up share capitals

- 4.2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone ent ity basis, the unaudited unconsolidated financial statements of the bidder can be considere d acceptable provided the bidder further furnishes the following documents for substantiati on of its qualification.
 - i. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
 - ii. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company
- 1.2.5 In cases where audited results for the last preceding financial year as on the date of Techn o- Commercial bid opening are not available, the financial results certified by a practicing C hartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno- Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 4.2:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- 3. Net worth means the sum total of the paid-up share capital and free reserves. Fre e reserve means all reserves credited out of the profits and share premium accoun t but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Pr ofit and Loss account and miscellaneous expenses to the extent not adjusted or wr itten off, if any, shall be reduced from reserves and surplus.
- 4. In case of any executed value submitted by the bidder is in foreign currency, Bill S elling Exchange Rate established by State Bank of India as on the date of Techno-Commercial bid opening shall be used.

- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
