3.0 The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the NTPC tender website <https://eprocurentpc.nic.in>.

The Bidder would be required to register in the website. First time users are required to register themselves on NTPC tender website after filling up the required details. Users whose email address has not been linked to a vendor code allotted by NTPC/ first time users not allotted any vendor code by NTPC, should send a copy of the registration details to the e-mail address specified in this NIT under Address for Communication with following details at least three working days prior to Technical Opening Date:

- i. Request on the letter head of the Company
- ii. Copy of GST Registration

- iii. Copy of PAN no.
- iv. Email ID and Contact No.
- v. Name and Designation of the contact person
- vi. Cancelled cheque & EFT form duly verified by bank.

4.0 Brief Scope of Work and other Specific details:

Repair & Modifications including supply of main chilled water pipe lines network of HVAC piping system on roof at NTPC-PMI, Sector-16A, Noida.

5.0 Downloading / Issuance of bidding documents to any bidder shall not construe that bidder is considered qualified.

- 6.0 'Class-I local suppliers' and '~~Class-II local suppliers~~' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

7.0 Qualifying Requirements for Bidders:

- 7.1 The bidder should have executed work for R&M (Renovation & Modernization) of HVAC system or supply, installation & commissioning of HVAC system in India, in the preceding Seven (7) years, which is in successful operation for minimum one (1) year as on date of techno-commercial bid opening and having contract value of any one of the following:

a) One (1) work having executed value not less than Rs. 86 Lakh (Indian Rupees Eighty-Six Lakh only)

OR

b) Two (2) works each having executed value not less than Rs. 54 Lakh (Indian Rupees Fifty-Four Lakh only)

OR

c) Three (3) works each having executed value not less than Rs. 43 Lakh (Indian Rupees Forty-Three Lakh only).

Following Notes applicable for above Clause 7.1:

- 1). The work "executed" means the bidder should have achieved the criteria specified in the QR, even if the total contract is not completed /closed.

2). In case of contracts under execution prior to the date of bid opening, the value of work completed till the date of bid opening will be considered provided the value of executed work is certified by the employer.

3). The value of executed work is exclusive of applicable tax / GST. In case of contract is inclusive of taxes, bidder should provide the break-up of basic value and taxes.

4). Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

5. In case, bidder has executed reference work, under two orders one for supply and one for services separately for the same installation, combined value of both the orders shall be considered as a single order for the purpose of evaluation.

7.2 The average annual turnover of the bidder, in the preceding three (3) financial years as on the date of bid opening shall not be less than Rs.72 Lakh (Indian Rupees Seventy-Two Lakh only)

In cases where audited results for the last financial year as on the date of bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable.

In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.

Further a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Note applicable for above clause-7.2:

While computing the turnover other income shall not be considered.

8.0 The format of the Bank Guarantee shall be in accordance with the form of Bank Guarantee towards Bid Security/EMD/Performance security/*Security for the Deed of Joint Undertaking (if applicable)/*Advance payment (if applicable) included in the Employer's Bidding Documents only. In addition, the format of the Insurance Surety Bond shall also be in accordance with the form of Insurance Surety Bond towards Bid security/Performance security/*Security for the Deed of Joint Undertaking (if applicable) included in the Employer's Bidding Documents only. Any bid not accompanied by an acceptable bid security in a separate sealed envelope shall be rejected by the Employer as being non-responsive. 'Original Hard copy' for submission of BGs towards Performance security is mandatory.

It is also noted that E-BG also acceptable in place of physical BG.

9.0 The Contractor and its employees along with its Associate/ Collaborator/ Sub-Contractors / Sub-Vendors / Consultants / Service Providers and all other persons associated with Employer in the performance of Contract shall strictly adhere to Employer's Anti-Bribery and Anti-Corruption (ABAC) Policy displayed on website <https://ntpctender.ntpc.co.in/> under section 'policy docs'. The Contractor and its employees along with its Associate/ Collaborator/ Sub-Contractors / Sub-Vendors / Consultants / Service Providers and all other persons associated with Employer in the performance of Contract shall comply with all applicable laws and regulations relating to anti-corruption and anti-bribery and the ABAC Policy of Employer.
Bidders must submit a declaration as per Annexure-16 towards acceptance of Anti-Bribery and Anti-Corruption (ABAC) Policy.

10.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Notice Inviting Tender [NIT] for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
