4. Qualifying Requirements for Bidders:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

4.1 **Technical Criteria:**

The Bidder should have Designed, Manufactured, Installed/Supervised installation and Commissioned/ Supervised commissioning of at least one (01) no. of 400 KV or above class Generator Transformer of at least 200 MVA capacity (either three phase transformers as a single unit or single-phase transformer) which should be in successful operation for at least two (02) years prior to the date of techno commercial bid opening.

Notes for 4.1

1. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

4.2 Financial Criteria of the bidder:

- 4.2.1 The average annual turnover of the bidder, in the preceding three (03) financial years, re ckoned as on the date of Techno-commercial bid opening shall not be less than **Rs 17.47** Crores (Rupees Seventeen crores Forty-seven lakhs only).
- 4.2.2 In case a bidder does not satisfy the annual turnover criteria, stipulated above at Cl. 4.2.1 on its own, its Holding Company would be required to meet the stipulated turnover r equirements at Cl. 4.2.1 above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 4.2.3 Net Worth of the bidder shall not be less than 100% of the bidder's paid up share capital as on the last day of the preceding financial year on the date of Techno-commercial bid o pening. In case the Bidder meets the requirement of Net Worth based on the strength of i ts Subsidiary(ies) and/or Holding Company and/or Subsidiaries of its holding companies w herever applicable, the Net Worth of the Bidder and its Subsidiary(ies) and/or Holding Company and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of their total paid up share capital. - 4.2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone ent ity basis, the unaudited unconsolidated financial statements of the bidder can be considere d acceptable provided the bidder further furnishes the following documents for substantiati on of its qualification.
 - i. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
 - ii. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company
- 1.2.5 In cases where audited results for the last preceding financial year as on the date of Techn o- Commercial bid opening are not available, the financial results certified by a practicing C hartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno- Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 4.2:

- 1. Net worth means the sum total of the paid-up share capital and free reserves. Fre e reserve means all reserves credited out of the profits and share premium accoun t but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Pr ofit and Loss account and miscellaneous expenses to the extent not adjusted or wr itten off, if any, shall be reduced from reserves and surplus.
- 2. Other income shall not be considered for arriving at annual turnover.
- 3. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- 5. Notwithstanding anything stated above, the Employer reserves the right to assess the ca pabilities and capacity of the Bidder/ his collaborators /associates/ subsidiaries / group co mpanies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
