## **7. Eligibility for Participation:**

NTPC enlisted vendors for the Contract Enlistment Group (CEG No: AST-01, Name: "TRANSPORTATION OF ASH THROUGH ROAD FROM NTPC") with Average Annual Turn Over (AATO) & EC (Execution Capability) both equal to or more than Rs . 41,95,81,354.85/- can only participate in this tender. Others shall not be considered. Applications by vendors not meeting these criteria shall be rejected during technical evaluation.

If non enlisted/rejected vendors are interested to participate, can do so in future tenders first by enlisting themselves for the respective product category (CEG ). They shall have to visit NTPC CPC website [www.vendor.ntpc.co.in](http://www.vendor.ntpc.co.in) and submit online application against items/services (Material /Contract Enlistment Groups) of their choice. If they meet the criteria stipulated in the Qualifying Requirement, they shall be enlisted in line with the Terms and Conditions of enlistment.

**All participating vendors in this tender shall submit their latest enlistment certificate issued to them with mention of AATO & EC values for the item category (CEG) or submit any other proof of their enlistment in which AATO & EC along with CEG is mentioned.**

8. “The format of the Bank Guarantee shall be in accordance with the form of Bank Guarantee towards Bid Security/EMD/Performance security included in the Employer’s Bidding Documents only (refer Section-VIII: Forms and Procedures (Book 3 of 3)). 10. MSEs seeking exemption for EMD and Purchase Preference shall select appropriate option on GeM portal (separately for each i.e. EMD & purchase preference) and should enclose attested/self-certified copy of UDYAM registration certificate, failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.

### **11. Instructions for filling the Price Bid:**

(1) The Bidder is required to quote **Lumpsum Price (Including GST)** in GeM Bid for each BOQ item (total 04 items). Bidders are requested to kindly go through the Schedule of Quantities and Quote the cost for each item inclusive of GST.

(2) The Break-Up of applicable GST is required to be quoted in Attachment-14 as per the provisions of the bidding documents.

(3) Bidders are requested to must check the total package cost against the estimated cost of NIT

before submission of GEM Bid online to avoid any confusion later on. After opening of technical Bids, Bidder are not allowed to modify/change the rates/amount what so ever.

(4) Other terms and Conditions shall be as GCC & SCC of Civil.

### **10. Evaluation and Splitting criteria:**

1. Bid Price: Bidder shall quote the price including GST for all the item no. 1,2,3, and item no 4 against the Tender Price. Further, Bidders note that the Estimated Unit Rate for each line item (exclusive of GST) is displayed in price Bid schedule and accordingly Bidder has to offer their amount for each line item (inclusive of GST).

2. Each Bidder must submit Attachment-14 (Declaration regarding GST) being provided under the bid documents.

3. Splitting : Applicable. Details as per "Technical Specification and Scope of Work"

4. MSE Benefit : Applicable . Bidders to go through the tender documents for the same.

11. Bidder to upload Enlistment certificate, **Attachment 14 -Declaration of GST , Attachment -17 Compliance to “Conflict of Interest” provisions, Attachment 15- UNDERTAKING FOR COMPLIANCE OF IMPORTANT CONDITIONS OF TENDER BY BIDDER, MSE certificate (if applicable), Power of Attorney** in Additional ATC Documents.
12. Scanned copy of the EMD BG shall be uploaded by Seller in the online bid and hard copy of the same will have to be submitted directly to the Buyer within 5 working days of bid opening, failing which the bid may be treated as incomplete & may lead to rejection of the bid by buyer without making any reference to the seller. Bidders are requested to refer details regarding the same in BDS clause 10 of tender documents.
