### **1.0 INTRODUCTION:**

NTPC is the largest power generating major in the country. It was incorporated in the year 1975, with the objective of planning, promoting and organizing an integrated development of power stations in India. It has today emerged as an 'Integrated Power Major', with a significant presence in the entire value chain of power generation business.

With an installed capacity of 75,000+ MW, presently, NTPC generates power from Coal, Gas, Solar, Wind & Hydro. It has also diversified into coal mining, power equipment manufacturing, power trading & distribution. With an increasing presence in the power value chain, NTPC has emerged as an Integrated Power Major. The ambitious plan of NTPC to diversify into coal mining business for enhancing fuel security to its coal fired power plants is now delivering the results, coal production from Pakri Barwadih, Dulanga & Talaipalli Coal Blocks has already started.

Presently NTPC is developing 6 coal blocks allocated directly to it and one coal block of PVUNL, a JV of NTPC with Govt. of Jharkhand, for captive consumption of the coal. The total peak rated annual production capacity of these coal blocks estimated to be 71 MMT to fuel approximately 15 GW of NTPC.

## **2.0 Background**

Kerandari Coal Mine block has been allocated to NTPC Ltd on 08.09.2015 by GOI vide order no 103/29/2015/NA (Annexure-I) for catering to the coal demand of Tanda Thermal Power Project stage II. MDO contract was awarded to M/s BGR Mining & Infra Limited on 01.02.2023. MDO has mobilized to site and mining activities have been started from 05.04.2023. Coal Production and dispatch started on 15.01.2024 and 05.03.2024 respectively. The Permanent evacuation system consisting of both conveyor system and railway line with loading bulb arrangement is envisaged for transportation of coal from the mine. The aforementioned evacuation system is likely to be completed in next 3 to 4 years. Till the completion of permanent evacuation system, NTPC intends to transport 30 million tonnes (tentative dispatch target is 10 MMT every year for 3 years respectively) of coal through road from Gopda village to Shivpur siding under BOT (Build Operate Transfer) model.

## **3.0 PURPOSE OF THE EOI**

3.1 NTPC desires to explore the possibility of evacuation of coal by road to nearest railway siding as an interim arrangement till the readiness of permanent evacuation system.

3.2 NTPC invites 'Expression of Interest' (EOI) from all reputed Indian firms/companies who have experience of transportation of coal by road, construction of road/ bridge/ culverts and liasioning work for getting clearances and leasing/ acquisition of land. The details received in EOI shall be used to set the qualification criteria for bidders. Subsequently competitive bidding shall be carried out for selection of bidder for coal transportation and construction of road.

*This invitation for Expression of Interest is not intended for empanelment or pre-qualification of bidders.*

#### 4.0 INTENDED BROAD SCOPE OF WORK

The broad scope of work for evacuation of coal by road to nearest railway siding is brought out below:

- (i) Transportation of coal from upcoming Truck Loading System at Gopda Village to Shivpur siding/ nearby Railway sidings and wagon loading of 30 MMT coal for a period of 3 years, starting from Nov'25 tentatively.  
**Coordinates for Gopda and Shivpur siding is attached.**
- (ii) Construction of road/ bridge/ culvert etc under BOT (Build Operate Transfer) model.
- (iii) Land leasing/ acquisition for Construction of road/ bridge/ culvert etc.
- (iv) Liaisoning with all administrative & other authorities/ bodies like Village Panchayat etc.
- (v) Clearance from Forest, Environment, and any other departments/ agencies for rapid construction of road and smooth transportation of coal.

The above-mentioned scope of work is indicative only. The firms/companies may choose to offer additional services deemed necessary for effective execution of the coal evacuation by road.

#### 5 INFORMATION REQUIRED AS PART OF EOI

Prospective parties are required to submit the information as mentioned below along with their EOI in the attached Formats:

- (i) Company profile
- (ii) Financial Capability
- (iii) Implementation methodology
  - The agency shall furnish detailed methodology with timeline for execution of work mentioned at 4.0 above.
  - The agency shall furnish their comments on 'BOT Model' for construction of road. The agency may also suggest other than BOT model of operation.
  - The agency may also suggest for splitting of the work etc., for better participation & timely execution.
  - The agency may also explore and propose any other nearby siding for economically transportation of coal.

- The agency may use/ construct any road as per the law (Coordinate of TLS at Gopda and Shivpur siding (proposed) is attached).
- (iv) Past Experience details.
- (v) Any other relevant information in this regard.

## **6 INSTRUCTIONS TO THE APPLICANTS**

- 6.1 All costs incurred by Applicant for preparing and submitting the EOI, in providing clarification or attending discussion/ meeting or for site visits, stationery, or any other expenses whatsoever shall be borne by Applicant's themselves.
- 6.2 This Expression of Interest document is not transferable.
- 6.3 The language for submission of document shall be English.
- 6.4 The enclosed Annexures shall be filled in completely and wherever not applicable it should be written as "Not Applicable".
- 6.5 The person signing the document submission on behalf of the Applicant shall enclose Power of Attorney duly authorized and notarized for the same. The Power of Attorney shall be backed by copy of the board resolution of Company.
- 6.6 Financial data should be given in Indian Rupees only.
- 6.7 The information furnished with the EOI must be sufficient for processing and assessment.
- 6.8 In case the Applicant intends to give additional information for which specified space in the given format is not sufficient, it can be furnished in enclosed sheets.
- 6.9 All the pages of the EOI and Annexure should be signed and corrections and over writings should be countersigned by the authorized signatory.

6.10 NTPC reserves the right to cross check and confirm the information details furnished by the Applicants in the document.

## 7 Deadline for Submission of EOI

EOI must be submitted through email no later than **17:00 Hrs 01.07.2024**. EOI received after aforesaid deadline shall not be entertained.

NTPC may, at its discretion, extend this deadline for submission of EOI in which case all rights and obligations of Employer and applicant will thereafter be subject to the deadline as extended.
