4. Qualifying Requirements for Bidders:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

4.1 **Technical Criteria:**

4.1.1 (a) The bidder should be the 'manufacturer of conductivity Analyser 'and / or' Sodiu m Analyser' (*Please refer Note 7 of Notes for 4.1.1 for details*)

(b) The Bidder should be a Subsidiary / Authorized channel partner/ Authorized dealer of the OEM [as described in 4.1.1 (a) above] as on the date of Techno-commercial Bid Opening.

- 4.1.2 The Bidder should have executed the order(s) for 'water analyser(s)', as detailed below in the preceding seven (7) years as on date of techno commercial bid opening.
 - 1. One (1) order having executed value not less than **Rs. 48 Lacs**

Notes for 4.1.1:

- 1. The word "Executed" mentioned above means that the bidder should have achiev ed the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considere d acceptable.
- 3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 4. The bidder must submit Latest annual report OR NSIC / SSI / MSME registration cer tificate / BIS license / ISO certificate / any other statutory document as a proof of b eing manufacturer as per QR.

- 5. For authorized representative of the manufacturer, the credentials of both bidder as well as its principal will be considered qualified under QR evaluation of clause 4.1.2.
- 6. In case, bidder has executed reference work under two orders one for supply and one for services separately for the same installation, both the orders shall be considered as a single order for the purpose of evaluation.
- 7. (a) If a vendor prefers to quote either only for Conductivity analyzer OR only for S odium analyzer then, vendor has to provide credential details as per requirement of clause 4.1.1 for quoted item only.
 - (b) If a vendor prefers to quote for both Conductivity analyser and Sodium analyse r then, vendor has to provide credentials details as per requirements of clause 4.1. 1 for both the quoted items.

4.2 Financial Criteria:

- 4.2.1 The Average Annual Turnover of the Bidder should not be less than **Rs. 60 Lacs (Rupee s Sixty lacs only)** during the preceding three (3) completed financial years as on the dat e of Techno-Commercial bid opening.
- 4.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 4.2.1 above on it s own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 4.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 4.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone e ntity basis, the unaudited unconsolidated financial statements of the bidder can be consi dered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:
 - I. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.
 - II. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statem ents form part of the Consolidated Annual Report of the company.
- 4.2.4 In case where audited results for the last financial year as on the date of techno commer cial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

NOTES for 4.2:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascr ibed to them as per Companies Act of India, in vogue.
- 3. **Net worth means** the sum total of the paid-up share capital and free reserves. F ree reserve means all reserves credited out of the profits and share premium acco

unt but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

- 5. Notwithstanding anything stated above, the Employer reserves the right to assess the ca pabilities and capacity of the Bidder/ his collaborators /associates/ subsidiaries / group co mpanies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer. The physical assessment shall include but not be limited to the assessment of office/facilities/banker's/reference workers by Employer. A negative determination of such assessment of capacity and capabilities may result in rejection of the bid.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
