If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are

# 1.0 **QUALIFYING REQUIREMENTS FOR BIDDERS.**

The bidder who wishes to participate in the bidding shall meet the Qualifying Require ments stipulated hereunder

## 1.0 Technical Criteria:

The bidder should have executed work(s) for 'Operation Assistance and/or Operation and/or Operation & m aintenance and/or Housekeeping and/or Upkeeping and/or Manpower assistance' in a Coal-based Thermal Power Plant for an executed value of at least **285 Lakhs (Rupees Two Hundred Eighty Five Lakhs onl y)** in a maximum of three contracts within preceding seven (07) years prior to the date of Techno- Comme rcial bid opening.

#### Notes for Technical criteria :

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria spe cified above, even if the total contract is started earlier and/or is not completed/closed..
- 2. In case of orders under execution, the value of work executed prior

to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered accepta ble.

3. Reference work executed by the bidder as a sub-contractor may also be

considered provided that the certificate issued by the main contractor is duly certified by owner specif ying the scope of work executed by the subcontractor

in support of qualifying requirements.

4.Reference works executed by the bidder, as a member of joint Venture / Consortium / Associate can also be considered provided:

a) The allocation of scope of work between the partners of the joint Ventures / consortium / Associate is clearly defined in the executed joint venture agreement / consortium agreement / deed of joint und ertaking and the bidder's scope of work and break-up of quantities executed by them as individual co ntribution in the joint Venture / Consortium / Associate, duly authenticated by the Project Authority/O wner, meet the relevant provisions of eligibility criteria.

b) In case the reference work has been executed by the bidder in an integrated joint venture wherein allocation of scope of work and break-up of quantities between the partners is not clearly specified in the integrated joint venture Agreement, then for establishing the eligibility as per technical criteria 1.1 of QR, the credit of executed quantities can be claimed by the bidder in the ratio of bidder's share in t he integrated joint Venture Agreement, provided the applicant establishes that it regularly undertakes works mentioned in QR. The executed works/ quantities by the integrated joint venture shall be duly a uthenticated by the Project Authority/owner."

5.For arriving at the executed value of work specified above, basic amount only shall be considered. I n case contract is inclusive of taxes, bidder should provide the break – up of basic value and taxes.

## 2.0 Financial Criteria:

2.1 The Average Annual Turnover of the Bidder, should not be less than **. 356 Lakhs (Rupees Three Hun dred Fifty Six Lakhs only) during the preceding three (3)** completed financial years prior to the date of Techno-Commercial bid opening

2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl.2.1 above on its own, its Holdi ng Company would be required to meet the stipulated turnover requirements at Cl. 2.1 above, provided th at the net worth of such Holding Company as on the last day of the preceding financial year is at least equ al to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would b e required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Comp any, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditio nal and irrevocable financial support for the execution of the Contract by the bidder in case of award.

2.3 The Net Worth of bidder shall not be less than 100% of the bidder's paid up share capital as on the last day of the preceding financial year. In case the Bidder me ets the requirement of Net worth based on the strength of its Subsidiary(ies) a nd/or Holding company and/or Subsidiaries of its holding companies wherever applicable, the Net worth of the Bidder and its Subsidiary(ies) and/or Holding company and/or Subsidiary (ies) of the Holding Company, in combined manner s

hould not be less than 100% of their total paid up share capital. However individually, their Net worth should not be less than 75% of their respective paid up share capitals.

Net worth in combined manner shall be calculated as follows:

Net worth (combined)= $(X1+X2+X3)/(Y1+Y2+Y3) \times 100\%$ 

Where X1, X2, X3 are individual Net worth which should not be less than 75% of the respective paid-up share capitals and Y1, Y2, Y3 are individual paid up sh are capitals.

- 2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided t he bidder further furnishes the following documents for substantiation of its qualification.
  - (a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of t he Audited consolidated financial statements of its Holding Company.
  - (b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the biddi ng documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 2.5 In cases where audited results for the last preceding financial year as on the date of Techno-Commerci al bid opening are not available, the financial results certified by a practicing Chartered Accountant sh all be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Char tered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Fur ther, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding doc uments stating that the financial results of the Company are under audit as on the date of Techno-Co mmercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial results for the practicing Chartered Accountant certifying the financial necessary of the practicing Chartered Accountant certifying the financial parameters is not available.

## Notes for 2.0:

- i. Other income shall not be considered for arriving at annual turnover.
- ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Co mpanies Act of India, in vogue.
- iii. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves c redited out of the revaluation of the assets, write back of depreciation provision and amalgamatio n. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

- 2.0 Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account ( wherever applicable) undertaken/ signed by a Member of Institute of Chartered Acco untant of India (ICAI), which Bidders submit in support of compliance to Qualifying Re quirements (QR), will carry Unique Document Identification Number (UDIN) generate d in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
- 3.0 Notwithstanding anything stated above, the Employer reserves the right to assess the credentials/capabilities/capacity of the Bidder/ his collaborators / associates/ subsidia ries / group companies to perform the contract, should the circumstances warrant su ch assessment in the overall interest of the Employer.

The physical or any mode of assessment/verifications by Employer shall include but n ot be limited to the assessment/verifications of office/ facilities/ banker's/ submitted r eference works in lieu of credentials. A negative determination of such assessment of credentials/capacity/capabilities may result in rejection of the bid.

- 4.0 The reference works whose details have been declared in their bid shall only be consi dered to ascertain the bidder's compliance to the specified qualifying Requirement ( QR). The Employer at its discretion may seek any clarification and/or documentary e vidence only for the reference works as mentioned above. However, no change or su bstitution of the reference works by new/additional plant for conforming to the specifi ed qualifying Requirement shall be sought, offered or permitted".
- 5.0 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 an d its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- 6.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered wi th the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Techno logy (ToT) arrangement with an entity from a country which shares a land border wit h India, will be eligible to bid only if the bidder is registered with the same competen t authority.

However, the said requirement of registration will not apply to bidders from those co untries (even if sharing a land border with India) to which the Government of India ha s extended lines of credit or in which the Government of India is engaged in develop ment projects.

7.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / inten ding bidder shall have any claim arising out of such action.
