- 11. The tenderer should not have been black listed by any of the NTPC/Government /PSU/ Trusts and no case should be pending or filed or pending in any courts for any illegal activities.
- 12. The Property/Premises offered should be in good and ready to occupy condition.
- 13. During the agreed lease period with NTPC, Party is not permitted to enter into lease agreement with any third party for property hired by NTPC.

The amount spent on such activities shall be recovered from the rent amount for the period of occupancy for which Party shall have no objection.
- 18. On the condition that the NTPC continues to pay the lease rent hereby reserved and observe and perform the covenants on their part herein contained, the NTPC shall peacefully and quietly hold and enjoy the demised premises/property during the said terms without any interruption or disturbance by the Party or any person claiming under him or in trust of his or any other person whatsoever and Party shall defend the same at his own costs.
- 19. The NTPC may utilize parts of the premises for gardening or other aesthetic activities at their own cost to which the Party shall have no objections.
- 20. The Party shall paint the premises offered before handover. If Party fails to do so the NTPC will have right to get it done at the cost of Party and the amount so spent will be adjusted with the payable lease rent. However, Party shall not object if NTPC decides to paint the entire/any part of the premises at their own cost to meet their requirement.
- 21. Day to day minor repair works such as fuses, leakage of water taps, wash basins, other fitments

/ utilities in the Bath Room / Kitchen etc. shall be done by the NTPC at their own cost, it shall be the duty and obligation of the Party to upkeep the premises in good condition and to replace any broken items / fixtures which are part of the building and also carry out the major repairs such as leakages in electricity and sanitary water pipes or cracks, repair of motor for supply of water etc. These will be attended by the Party at his cost within 7 days of such defects being notified to the Party by the NTPC. Provided that if the Party fails to carry out such necessary repairs within 7 days time, the NTPC shall be at liberty to carry out the same by itself and deduct the amount spent on such repairs from the rent of the next month.

- 22. The Party being the legal owner of the premises is fully entitled to execute the Lease Deed and that NTPC will hold the lease free and harmless of any demands, claims, action or proceedings by others in respect of quiet possession of the demised premises.
- 23.
