The Bidder would be required to register in the website. First time users are required to register themselves on NTPC tender website after filling up the required details. Users whose email address has not been linked to a vendor code allotted by NTPC/ first time users not allotted any vendor code by NTPC, should send a copy of the registration details to the e-mail address specified in this NIT under Address for Communication with following details at least three working days prior to Technical Opening Date:

- vi. Cancelled cheque & EFT form duly verified by bank.

4.0 Brief Scope of Work and other Specific details:

Repair & Modifications including supply and Installation of Industrial 5000 LPH Reverse Osmosis Plant for HVAC system at NTPC-PMI, Sector-16A, NOIDA with CAMC for a period of 03 years.

5.0 Downloading / Issuance of bidding documents to any bidder shall not construe that bidder is considered qualified.

6.0 'Class-I local suppliers' and '~~Class-II local suppliers~~' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

7.0 Qualifying Requirements for Bidders:

7.1 The bidder should have executed / completed job of supply, Installation & Commissioning of 4000 LPH or more capacity Reverse Osmosis Plant in the preceding Seven (7) years in India as on the date of techno-commercial bid opening and having contract value of any one (a/b/c) of the following :

- a) One work having executed value not less than Rs. 23.59 Lakh (Indian Rupees Twenty-Three Lakh Fifty-Nine thousand only).

OR

- b) Two works each having executed value not less than Rs.14.75 Lakh (Indian Rupees Fourteen Lakh Seventy-Five thousand only).

OR

- c) Three works each having executed value not less than Rs.11.80 Lakh (Indian Rupees Eleven Lakh Eighty thousand only).

The above plant should have been in operation for a period of One (1) year prior to the date of techno commercial bid opening.

Notes for 1.0:

Note-1: The work "executed" means the bidder should have achieved the criteria specified in the QR, even if the total contract is not completed / closed.

Note-2: In case of contracts under execution as on date of bid opening, the value of work completed till the date of bid opening will be considered provided the value of executed work is certified by the employer.

Note-3: The above value of executed work is exclusive of applicable tax / GST.

7.2 The average annual turnover of the bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening shall not be less than Rs.25.82 Lakh (Indian Rupees Twenty-Five Lakh Eighty-two thousand only).

Note for 2.0:

(a) While computing the turnover other income shall not be considered.

(b) In cases where audited results for the last financial year as on the date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

8.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Notice Inviting Tender [NIT] for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
