1. Buyer Added Bid Specific ATC

- **1.**All Terms & Conditions of ATC must be complied by the Bidder. On Non-Compliance of it, the BID will be rejected Technically.
- **2.** Bidder must mandatorily fill the Annexure-12 (QR summary sheet) in support of reference documents fo r meeting QR and upload the same along with the technical bid in Technical Cover. (Refer ITB clause 26). N umber and details of projects/stations for which Bidder is seeking qualification and has submitted requisite EMD accordingly is to be indicated in Annexure-12 of QR Summary sheet and same shall be considered for technical Evaluation.
- **3.** Evaluation and award shall be done projects/stations wise. A Bidder can apply for one or more than one projects/stations and in that case the values of EMD will be added for the quoted plants to arrive at the requisite EMD.
- **4.** Bidder is required to submit the details of quoted projects/stations along with EMD document on GeM p ortal. Bidders QR evaluation shall be done for the quoted/declared projects/stations based on receipt of re quisite EMD (i.e. sum of the EMD values indicated in SI. No. 3.0 of SPC for the plants applied for).
- **5.** In case EMD submitted by bidder is found short than the requisite EMD for the quoted plants, its bid will be rejected.
- **6.** Bidders shall be evaluated only for the projects/stations quoted by them and no change or substitution in quoted projects/stations shall be considered.
- **7.** The Techno-Commercial Bid should not contain any price content entry. In case, the Techno-Commercial Bid is found to contain any price content, such bid shall be outrightly rejected.
- **8.** KM travelled (which is mentioned as 25000 km in GeM technical specification) should be read as **5000 KM**.

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम <u>और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
