1. 1.1.1 Route-1

1. The word "Executed" mentioned above means that the bidder should have ac hieved the

criteria specified above, even if the total contract is started earlier and/or is not completed/closed.

- 2. Similar Work means "Supply of Gas Turbine and/or Gas Turbine Componen ts/Spares".
- 3. In case of orders under execution, the value of work executed prior to the date of Techno-

Commercial bid opening duly certified by bidder's client shall be considered accept able.

4. For arriving at the executed value of work specified above, basic amount only shall be

considered. In case contract is inclusive of taxes, bidder should provide the break – up of basic

value and taxes.

1.2: Financial Criteria:

1.2.1 The Average Annual Turnover of the Bidder should not be less than Rs. 269 Lakh (Rupees Two hundred sixty nine lakh only) during the preceding three (3) completed financial

years as on the date of Techno-Commercial bid opening.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its

own, its Holding Company would be required to meet the stipulated turnover requirements at Cl.

1.2.1 above, provided that the net worth of such Holding Company as on the last day of the

preceding financial year is at least equal to or more than the paid-up share capital of the Holding

Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of awa

1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alo ne entity basis, the unaudited unconsolidated financial statements of the bidder can be co

nsidered acceptable provided the bidder further furnishes the following documents for sub-

stantiation of its qualification.

Copies of the unaudited unconsolidated financial statements of the bidder along with copie s of the Audited consolidated financial statements of its Holding Company.

A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form p art of the Consolidated Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 1.2:

Other income shall not be considered for arriving at annual turnover.

"Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them a s per Companies Act of India, in voque.

Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not inc lude reserves credited out of the revaluation of the assets, write back of depreciation provi sion and amalgamation. Further, any debit balance of Profit and Loss account and miscella neous expenses to the extent not adjusted or written off, if any, shall be reduced from res erves and surplus.

In case of any financial criteria submitted by the bidder in foreign currency, the

exchange rate as on 7 days prior to the date of Techno-Commercial bid opening shall be u sed.

Notes-

NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bi dder shall have any claim arising out of such action. Further, NTPC reserves right to amen d any bid/tender conditions through appropriate CORRIGENDUM published in the portal at any time. NTPC also reserves the right to extend/change the bidding schedule through publishing necessary CORRIGENDUM in the portal if the situation demands so at any time. The corrigendum as decided by NTPC and deemed fit would be published in the portal as per provisions therein. This prevails over the relevant provisions elsewhere in the bid document. The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
