1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1.0 **Qualifying Requirements:**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirement s stipulated hereunder:

1.1 : Technical Criteria:

1.1.1 Bidder should be a supplier of steel pipes of diameter 500 mm or higher size.

AND

Bidder should have executed order(s) for supply of metallic pipes within preceding seven (07) years prior to the date of Techno-Commercial bid opening in any of the following mann er: A. One (1) order having executed value not less than Rs. 266 Lakh

OR

B. Two (2) orders having executed value not less than Rs. 166 Lakh each

OR

C. Three (3) orders having executed value not less than Rs. 133 Lakh each

Notes for Technical Criteria:

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria

specified above, even if the total contract is started earlier and/or is not completed/closed.

2. In case of orders under execution, the value of work executed prior to the date of Techn o-Commercial

bid opening duly certified by bidder's client shall be considered acceptable.

3.For arriving at the executed value of work specified above, basic amount only shall be c onsidered. In

case contract is inclusive of taxes, bidder should provide the break – up of basic value and taxes.

4. In case Rate Contract is submitted in support of QR Cl No. 1.2, then executed value agai nst the RC shall be considered as execution against single Order for QR evaluation.

1.2 Financial Criteria:

1.2.1 The Average Annual Turnover of the Bidder, should not be less than Rs. 332 Lakh (R upees Three Hundred Thirty Two Lakhs only) during the preceding three (3) completed fin ancial years as on the date of Techno-Commercial bid opening.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its

Holding Company would be required to meet the stipulated turnover requirements at Cl. 2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alo ne entity basis, the unaudited unconsolidated financial statements of the bidder can be co

nsidered acceptable provided the bidder further furnishes the following documents for sub stantiation of its qualification.

i. Copies of the unaudited unconsolidated financial statements of the bidder along with cop ies of the Audited consolidated financial statements of its Holding Company.

ii. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in t he bidding

documents, stating that the unaudited unconsolidated financial statements form part of th e Consolidated

Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practi cing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to su bmit the Certificate from practicing Chartered Accountant certifying its financial paramete rs, the audited results of three consecutive financial years preceding the last financial yea r shall be considered for evaluating the financial parameters. Further, a Certificate would b e required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-Comm ercial bid opening and the Certificate from the practicing Chartered Accountant certifying t he financial parameters is not available.

Notes for 1.2:

i. Other income shall not be considered for arriving at annual turnover.

ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to the m as per

Companies Act of India, in vogue.

iii. Net worth means the sum total of the paid up share capital and free reserves. Free rese rve means all

reserves credited out of the profits and share premium account but does not include reser ves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous ex penses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

Notes-

a. NTPC reserves the right to reject any or all bids or cancel / withdraw the Invit ation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / in tending bidder shall have any claim arising out of such action. b. Issuance of bid documents to any Bidder shall not construe that such bi dder is considered to be qualified.
