Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. # Notes for Clause No. 5.1 above:

 The word "Executed" mentioned above means that the bidder should have achieved t he criteria specified above, even if the total contract is started earlier and/or is not com pleted/closed.  In case of orders under execution, the value of work executed prior to the date of Tec hno- Commercial bid opening duly certified by bidder's client shall be considered accept able.

3. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying t he scope of work executed by the sub-contractor in support of qualifying requirements.

4. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break – up o f basic value and taxes.

## 5.2 Financial Criteria:

- 5.2.1 The Average Annual Financial Turnover (AATO) of the bidder during preceding th ree (03) consecutive financial years as on the date of Techno-Commercial bid ope ning should not be less than **Rs. 145 Lakh (Rupees One Crore Forty-Five lak h only).**
- 5.2.2 In case the Bidder does not satisfy the financial criteria, stipulated at CI. 5.2.1 above on its own, its Holding Company would be required to meet the stipulated turno ver requirements at CI. 5.2.1 above, provided that the net worth of such Holding C ompany as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bid der would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 5.2.3 In case the bidder is not able to furnish its audited financial statements on stand-a lone entity basis, the unaudited unconsolidated financial statements of the bidder c an be considered acceptable provided the bidder further furnishes the following do cuments for substantiation of its qualification:
  - Copies of the unaudited unconsolidated financial statements of the bidder alon g with copies of the audited consolidated financial statements of its Holding Co mpany.
  - b. A Certificate from the CEO/CFO of the Holding Company, as per the format encl osed in the bidding documents, stating that the unaudited unconsolidated finan cial statements form part of the consolidated annual financial statements of th e Holding Company.

5.2.4 In cases where audited results for the last financial year as on the date of Te chno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidd er is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three (03) consecutive finan cial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding document stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying financial parameters is not available.

3.0 Note for Clause No. 5.2 above:

1. Net worth means the sum total of the paid-up share capital and free reserv es. Free reserve means all reserves credited out of the profits and share premium a ccount but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted o r written off, if any, shall be reduced from reserves and surplus.

2. Other income shall not be considered for arriving at annual turnover.

 "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.

4.0 Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities a nd capacity of the Bidder/ his collaborators /associates/ subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.

The physical assessment shall include but not be limited to the assessment of office/facilities/ban ker's/reference workers by Employer. A negative determination of such assessment of capacity a nd capabilities may result in rejection of the bid.
