1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1.0 **Qualifying Requirements:**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulate d hereunder:

1.1 : Technical Criteria:

A) The bidder must be a Manufacturer / Authorized representative of manufacturer of "Self Contain ed Breathing apparatus".

AND

B) The bidder should have executed Order(s) for supply of "Self-Contained Breathing apparatus" d uring last seven (7) years reckoned as on the date of Techno-Commercial bid opening in any of the fo llowing manner:

1) 78 Nos. executed in a Single order

Notes for Technical Criteria:

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria

in the qualifying requirements at Clause 1.0, even if the total contract is started earlier and/or is not c ompleted/closed.

2. In case of orders under execution, the value of work executed prior to the date of Techno-Commer cial

bid opening duly certified by bidder's client shall be considered acceptable.

3. For arriving at the executed value of work specified above, basic amount only shall be considered. In

case contract is inclusive of taxes, bidder should provide the break - up of basic value and taxes.

4. In case of Authorized representative of Manufacturer, the bidder must submit bid specific

authorization certificate.

#### 1.2 Financial Criteria:

1.2.1 The Average Annual Turnover of the Bidder, should not be less than Rs. **119 Lakh (Rupees O ne Hundred Ninteen Lakhs only**) during the preceding three (3) completed financial years as on t he date of Techno-Commercial bid opening.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its

Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial ye ar is at least equal to or more than the paid-up share capital of the Holding Company. In such an eve nt, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Underta king from the Holding Company, supported by Board Resolution, as per the format enclosed in the bi d documents, pledging unconditional and irrevocable financial support for the execution of the Contra ct by the bidder in case of award.

1.2.3 In case the bidder is not able to furnish its **audited financial statements on stand-alone e ntity basis**, the unaudited unconsolidated financial statements of the bidder can be considered acce ptable provided the bidder further furnishes the following documents for substantiation of its qualific ation.

i. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

ii. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding

documents, stating that the unaudited unconsolidated financial statements form part of the Consolid ated

Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of Te chno-Commercial bid opening are not available, the financial results certified by a practicing Ch artered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certific cate from practicing Chartered Accountant certifying its financial parameters, the audited results of t hree consecutive financial years preceding the last financial year shall be considered for evaluating t he financial parameters. Further, a **Certificate** would be required from the **CEO/CFO** as per the form at enclosed in the bidding documents stating that the Financial results of the Company are under aud it as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### Notes for 1.2:

i. Other income shall not be considered for arriving at annual turnover.

ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per

Companies Act of India, in vogue.

iii. Net worth means the sum total of the paid up share capital and free reserves. Free reserve mean s all

reserves credited out of the profits and share premium account but does not include reserves credite d out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further , any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

Iv Financial figures are rounded off to nearest whole number in lakh.

a.
