- I. NTPC invites on-line bids on **Single Stage Two Envelope** Bidding basis (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders on **Open tender basis** for afore-mentioned package as per Scope of Work mentioned hereinafter.
- II. **Brief Scope of Work:** The Scope of work is broadly classified in three parts:
- i. Operation of Coal Handling Plant and Auxiliaries
 - ii. Housekeeping of CHP and associated area.
 - iii. Maintenance of coal handling plant equipment including mechanical, electrical, C&I system, Fire Fighting System, Cooling water, Dust Suppression and Service Water systems, ventilation system & other auxiliary systems as envisaged in CHP system of PBCMP

Detailed Scope shall be as per Technical Specification / Terms of Reference.

- III. NTPC intends to finance the aforesaid Package through Own Resources.

- V.** Bidder has to furnish the EMD in a sealed envelope separately offline along with other documents mentioned in the tender documents by the stipulated bid submission closing date and time at the address given below in accordance with the provisions set forth in the bidding documents. Bidders may submit the Bid Security/EMD amount through Electronic Fund Transfer (EFT). Refer item No. 3.0 of Bid Data sheet for Bank Details of NTPC for EMD submission.

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED. IN CASE, THE BID SECURITY IS SUBMITTED THROUGH ELECTRONIC FUND TRANSFER (EFT), BIDDER TO SUBMIT THE PROOF OF E-PAYMENT OF BID SECURITY EITHER IN SEPARATE SEALED ENVELOPE OR IN THE E-TENDERING PORTAL.

The EMD exemption shall be applicable to the Bidders as per MSE policy referred to in Bidding Document and as per GeM rules provided on GeM Portal. In case of obtaining MSE benefits, MSE (UDYAM only) certificate towards exemption of Bid Security / EMD needs to be submitted. - VII.** Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
- VIII.** The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the Gem Portal <https://gem.gov.in>. The Bidder would be required to register on the website.

No Hard Copy of bidding documents shall be issued.

- IX.** Only 'Class-I local suppliers' are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- X.** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- XI.** Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- XII.** Downloading / Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified.
- XIII.** NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.

Qualifying Requirements

1.0 Technical Criteria: The bidder should meet the technical criteria mentioned at 1.1(A) or/and 1.1(B)

1.1(A)The Bidder should have executed similar work during the preceding seven (07) years reckoned as on date of techno-commercial bid opening

Executed value not less than **Rs 1526 lakhs** in a **single contract**

Or

Executed value not less than **Rs 954 lakhs** in **two contracts** each

Or

Executed value not less than **Rs 763 lakhs** in **three contracts** each

Similar work is explained in the following paragraph:

The bidder should have executed the work of O&M of Coal Handling Plant of steel cord conveyor capacity 1000 TPH or more in any organization covering plant operation, Maintenance (Mechanical, Electrical, C&I) of Coal Handling Plant along with related sub- systems and auxiliaries in a power plant/any Industry in the preceding seven (7) years prior to the date of techno-commercial bid opening.

1.1(B) The bidder should have designed, manufactured/got manufactured, erected & commissioned at least one number integrated bulk material handling plant including all associated structural steel works and electrical works of having conveyor 1000 Metric tonnes per hour rated capacity or above for coal or other minerals which should have been in successful operation for at least one (1) year as on the date of techno-commercial bid opening.

NOTES for clause 1.1(A) above:

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
3. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.
4. For arriving at the executed value of work specified above, basic amount only shall be considered. In case of contract is inclusive of taxes, bidder should provide the break-up of basic value and taxes.

NOTES for clause 1.1(B) above:

1. The reference works executed by the bidder's group company / subsidiary company shall not be considered for meeting the qualifying requirements by the bidder.
2. Reference work executed by a bidder as a sub-contractor may also be considered provided the certificate issued by a main contractor is duly certified by Project Authority specifying the Scope and value of Work executed by the sub- contractor in support of qualifying requirements.
3. Necessary documentary evidence including client certificate in support of execution of the work to be submitted along with Techno-Commercial bid.

2.0 Financial Criteria:

- 2.1(a)** The **average annual turnover** of the bidder in preceding three (3) financial years as on the last date of the month preceding the month of publication of NIT shall not be less than **Rs 1907 lakhs (Rupees One thousand nine hundred & Seven lakhs only)**

In case a bidder does not satisfy the average annual turnover criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirement as above, provided that the net worth of such holding company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital, of the holding company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Holding Company's Board resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for execution of the contract by the bidder in case of award.

- (b) Net worth of the bidder** should not be less than **100% (hundred percent)** of the bidder's paid-up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net worth based on the strength of its Subsidiary/ies and /or Holding Company and/ or Subsidiaries of its holding company wherever applicable, the Net worth of the Bidder and its subsidiary(ies) and/or Holding company and/or subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% (hundred percent) of their total paid up share capital. However, individually, their Net worth should not be less than 75% (seventy five percent) of their respective paid-up share capitals.

Net worth in combined manner shall be calculated as follows. Net worth(combine)=(X1+X2+X3)/(Y1+Y2+Y3) x100

where X1, X2, X3 are individual net worth which shall not be less than 75% of the respective paid-up share capitals and Y1, Y2 and Y3 are individual paid up share capitals

- 2.2** In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the Bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

- i) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- ii) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual financial statements of the Holding company.

In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial year preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on date of Techno - commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for clause 2.0

- I. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of profit and loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- II. Other income shall not be considered for arriving at annual turnover.
- III. "Holding Company" and Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India

5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
