3.0 All bids must be accompanied by Earnest Money Deposit for an amount calculated as per formula mentioned below and in the form as stipulated in the RfS Documents:

**Earnest Money Deposit = [INR 11,58,000 x Rated cumulative Installed Capacity of Solar component (MW) as quoted by bidder + INR 13,86,000 x Rated cumulative Installed capacity of Wind component (MW) as quoted by the bidder + INR 4,80,000 x Rated cumulative Installed Capacity of the ESS component (MWh) as quoted by the bidder].**

**ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.**

4.0 MSEs (Micro and Small Enterprises) having UDYAM registration only are exempted from submission of Cost of RfS Document, Processing Fee & Earnest Money Deposit (EMD). For a Consortium to be eligible for exemption from submission of Cost of RfS document, Processing Fee & Earnest Money Deposit, all the members of the Consortium shall be registered as MSE.

5.0 **Qualifying Requirements for Bidders:**

Qualifying Requirements shall be as specified in the RfS documents.

6.0 NTPC reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.

7.0 Interested parties are required to get registered with M/s ISN Electronic Tender Services website <https://www.bharat-electronictender.com> (if not registered already).

The cost of the RfS documents as mentioned above is required to be submitted along with GSTIN and Organization ID registered with ETS portal or in the manner specified at 7.1 below. 8.0 Issuance of RfS Documents to any Bidder shall not construe that such Bidder is considered to be qualified. Bids shall be submitted online. Bidder shall furnish Earnest Money Deposit, Pass Phrases, Board Resolution and other documents separately offline as detailed in RfS Documents before the stipulated bid submission closing date and time at the address given below.

9.0 Transfer of RfS Documents purchased by one intending Bidder to another is not permissible.

10.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.
