C. Overhauling / Maintenance of Ducts

- 2. Cleaning of ash from ducts.

- 3. It includes activities like shifting of material, erection of platform, removal of insulation & other related jobs as per site requirement.
- 4. Other details shall be given as per site specific requirement in tender Documents.

D. HP Jet Cleaning of APH Baskets:

The scope of work includes to and fro transportation of sufficient numbers of H.P. jet pumps with accessories from vendor's site to respective locations. No separate payment will be done on this account. Party shall have to mobilize the pumps well in advance from the commencement of work (as intimated by NTPC). Cleaning of Air Preheater basket shall cover:

- 1. Transportation of pump and accessories at air heater floor or area where baskets are to be cleaned.
- 2. Cleaning of all the baskets.
- **3.** For above contractor shall deploy sufficient parallel gangs to carry out the cleaning work. Cleaning shall be certified by area engineer. Failure of proper cleaning work within stipulated time frame shall attract penalty as mentioned in tender enquiry.
- 4. Other details shall be given as per site specific requirement in tender Documents.

Note-

- 1. The vendor must have at least Two nos. of Trolley mounted and 04 nos. of portable HP jet cleaning machines.
- 2. Execution of the work of "HP Jet cleaning of APH Baskets for Boiler" may be done by the Agency itself, only if it has the past experience of executing such works in a Boiler of minimum 200 MW capacity or these works may be outsourced to only those sub-vendors who have the past experience of executing such works in a Boiler of minimum 200 MW capacity."
- 3. The approval for execution of Work by the Contractor himself or by his Subcontractor will be subjected to approval of EIC based on submission of experience details by the appointed Contractor for a particular package.
