(5) EMD exemption: Micro and Small Enterprises (MSEs) having UDYAM Registration, for goods pr

duced and services rendered, shall be exempted from paying Earnest Money Deposit. Such registered bidders will have to submit UDYAM Registration Certificate, as a proof of being MSE on GeM Portal.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
