Appointment of a transaction advisor to carry out detailed due diligence of VIDARBHA INDUSTRIES POWER LIMITED (VIPL) undergoing CIRP under NCLT

1.0 NTPC invites online bids on **Single Stage Single Envelope** basis for aforesaid Package, as per the Brief Scope of Work mentioned hereinafter.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

Class-I local suppliers only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

2.0 The Bidding Documents for the aforesaid package has been uploaded on e-tender Portal (NTPC Limited eProcurement Portal) and may be downloaded through the same.

3.0 BRIEF SCOPE OF WORK

The Consultant shall carry out detailed due diligence on VIPL, based on the information from NCLT, available in the public domain, provided by RP/lenders/creditors/promoters and through its own resources. Consultant scope broadly shall include, but not limited to, the following services:

- Detailed due diligence (Commercial, Financial, Tax, Contractual and Legal)
- Risk assessment & mitigation measures and SWOT Analysis
- Valuation of the Target
- Financial modelling with sensitivity analysis for business case

- Determination of covenants and condition precedents in case of Target transfer
- Assistance in preparation and submission of Resolution Plan/ bids
- Presentation before high level committee of NTPC
- **4.0** NTPC intends to finance the subject package through Own Resources.
- **5.0** Dates for Bid Submission and Opening shall be as displayed in the etender portal.
- 6.0 All bids must be accompanied by Bid Security for an amount of INR 2,00,000/(Rupees Two Lacs only) as per the provision of Instructions to Consultant (ITC). Bid security should be through Demand Draft / Banker's Cheque (in favour of NTPC Ltd., payable at NOIDA) / Bank Guarantee/ Insurance Surety Bond. However, MSEs* shall be exempted from paying Bid Security.

"ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

*Micro and Small Enterprises (MSEs) registered with Udyam Registration Portal as per MSMED Act 2006 for goods produced and services shall be eligible for MSE benefits.

It is advised that all the Prospective Bidders shall register and obtain Udyam Registration Certificate. It may be noted that w.e.f. 1st April 2022, Udyam Registration Certificate shall be only valid Certificate to avail the benefits as per Public Procurement Policy.

MSEs seeking exemption and benefits should enclose an attested/self-certified copy of registration certificate as a part of his bid, giving details such as stores/services, validity (if applicable) etc. failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.*

- 7.0 NTPC reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no Bidder / intending Bidder shall have any claim arising out of such action.
- This NIT is published on limited tender basis and is not an open invitation to quote. Participation in this tender is by invitation only and is limited to the shortlisted entities for this tender. Bids received from uninvited entities shall be treated as unsolicited & are liable to be rejected.
- **9.0** Issuance of Bidding Documents to any bidder shall not construe that such Bidder is considered to be qualified.
