1. NTPC invites on-line bids on **Single Stage Two Envelope Bidding basis** (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders for aforesaid package- for **NTPC EOC** as per the scope of work briefly mentioned hereinafter. NTPC intends to finance subject Package through Domestic Commercial Borrowings/Own sources.

**2. Brief Scope of Work:**

Scope of Work shall include the following:

- a) PART-A: TOWNSHIP O&M OF ELECTRICAL SYSTEM, FIRE FIGHTING SYSTEM, MAINTENANCE OF AC'S, WATER COOLERS & FRIDGES, LIFTS, HOUSEKEEPING WORKS, PEST CONTROL, O&M of OWC MACHINE AND SOLID WASTE COLLECTION.
  - b) PART-B: TOWNSHIP CIVIL, WATER SUPPLY, RO WATER PLANTS, HORTICULTURE, FLORAL DECORATION.
  - c) PART-C: EOC CIVIL, WATER SUPPLY, RO WATER PLANTS, WATER SOFTENING PLANTS, OWC MACHINES, HORTICULTURE, HVAC, FIRE, FLOWER ARRANGEMENT, FLORAL DECORATION, EOC MISC OFFICE WORKS.
  - d) PART-D: EOC HOUSEKEEPING, PEST CONTROL SERVICES, DRY CLEANING, FURNITURE MAINTENANCE, ROOM AC'S, WATER COOLERS, CANTEEN VENTILATION SYSTEM, O&M OF ELECTRICAL SYSTEM, ACCESS CONTROL SYSTEM, CCTV, AUTODOORS, LIFTS, O&M OF STP.

5. Bidder has to ensure the following documents to be submitted online, pursuant to ITB Clause 10, failing which bid is liable for rejection:

  - c) Integrity Pact (applicable- REFER STANDARD FORMATS & CHCKLISTS-VOLUME I, SECTION-IV FOR FURTHER DETAILS)
6. All bids must be accompanied by Tender Fees (Cost of Bidding Documents), Bid Security and Integrity Pact AS PER TENDER PROVISIONS. **Integrity Pact shall be submitted as per instruction mentioned in ITB/ SCC.**

**Tender Fee and Bid Security shall be submitted AS PER DETAILED INSTRUCTIONS given in ITB/ SCC. Online payment option for Tender Fee and Bid Security is made available at GepNIC portal. Bidders are requested to please avail the facility.**

**ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE TENDER FEES, BID SECURITY AND INTEGRITY PACT AS PER TENDER PROVISIONS; SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED. IN CASE, THE TENDER FEE AND BID SECURITY IS SUBMITTED THROUGH ELECTRONIC FUND TRANSFER (EFT), BIDDER TO SUBMIT THE PROOF OF E-PAYMENT OF BID SECURITY ON THE E-TENDERING PORTAL.**

## **7. QUALIFYING REQUIREMENTS FOR BIDDERS:**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

### **7.1 Technical Criteria**

7.1.1 The bidder should have experience of providing Facility management Services which includes the work of Civil Maintenance, Electrical Maintenance, Housekeeping, Maintenance of HVAC System & Maintenance of Firefighting System of Buildings for a minimum period of 12 Months through one or multiple orders in India in preceding seven years as date of opening of techno-commercial bid.

7.1.2 The bidder should have executed any one of the following work(s) of providing Facility Management Services with scope including Civil Maintenance, Electrical Maintenance and Maintenance of HVAC System/ Maintenance of Firefighting System in India in preceding seven years as on the date of opening of Techno-commercial bid:

- a) One executed work having value not less than **Rs. 1106.82 Lakh.**

Or

- b) Two executed works having value not less than **Rs. 691.76 Lakh** each.

Or

- c) Three executed works having value not less than **Rs. 553.41 Lakh** each.

Notes for clause 7.1.2 above:

- 1) The work “executed” mentioned above means the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed / closed.

However, the work executed must include Civil Maintenance, Electrical Maintenance and Maintenance of HVAC System/ Maintenance of Firefighting System as part of Facility Management Services as referred at Sl. No. 2.0 above.

- 2) In case of orders under execution, the scope and value of total work executed till the date of opening of Techno-Commercial bid opening shall be considered subject to submission of certificate from Client/ End user duly certifying the value and scope of work executed in such Contract/ PO / Work.

However, the work executed must include Civil Maintenance, Electrical Maintenance and Maintenance of HVAC System/ Maintenance of Firefighting System as part of Facility Management Services as referred at Sl. No. 2.0 above.

- 3) The above value of executed work(s) is exclusive of applicable tax/ GST.

## **7.2 Financial Criteria:**

7.2.1 The Average Annual Turnover of the Bidder, in the preceding Three (3) Financial Years as on the date of Techno commercial Bid Opening, shall not be less than Rs. Rs 1383.52 Lakhs.

In case the bidder does not satisfy the average annual turnover criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements as above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company’s Board Resolution as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.

7.2.2 The Net Worth of Bidder shall not be less than 100% of the bidder’s paid-up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net Worth based on the strength of its Subsidiary (ies) and / or Holding Company and/ or Subsidiaries of its Holding Companies wherever applicable, the Net Worth of the Bidder and its Subsidiary (ies) and / or Holding Company, in combined manner should not be less than 100% of their total paid up share capital. However individually, their Net Worth should not be less than 75% of their respective paid up share capitals.

Net worth in combined manner shall be calculated as follows:

Net Worth (combined) =  $(x1 + x2 + x3)/(y1 + y2 + y3) \times 100$  where x1, x2, x3 are individual net worth which shall not be less than 75% of the respective paid up share capitals and y1, y2 and y3 are individual paid up share capitals.

7.2.3 In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following further documents on substantiation of its qualification.

- Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company
- A certificate from the CEO/ CFO of the Holding Company as per the format enclosed in the bid documents stating that the unaudited unconsolidated financial statements form part of the consolidated annual report of the company.

7.2.4 In case where audited result for the last financial year as on date of Techno-Commercial bid

opening are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable. In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO / CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of techno-commercial bid opening and that the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for clause 7.2:

- i. Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted and written off, if any, shall be reduced from reserves and surplus.
  - ii. Other income shall not be considered for arriving at annual turnover.
  - iii. "Holding Company" and "Subsidiary" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
8. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators /associates/ subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer. The physical assessment shall include but not be limited to the assessment of office/facilities/banker's/reference workers by Employer. A negative determination of such assessment of capacity and capabilities may result in rejection of the bid.
  9. **'Class-I local suppliers' only are eligible to participate in this tender**, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
  10. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

11. NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
12. NTPC reserves right to amend any bid/tender conditions through appropriate CORRIGENDUMS published in the portal AT ANY TIME. NTPC also reserves the right to extend/change the bidding schedule through publishing necessary CORRIGENDUMS in the portal if the situation demands so AT ANY TIME. The corrigendum as decided by NTPC and deemed fit would be published in the portal as per provisions therein. This prevails over the relevant provisions elsewhere in the bid document. The corrigendum/amendment as published/posted in the portal will be binding on Bidders and it will be assumed that the information contained therein will have been taken into account by the Bidder in its bid. Bidders are advised to regularly check the tender regarding posting of Amendments/Corrigendums, if any.
13. Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of

Bidder's representatives who choose to attend the bid opening.

15. **IMPORTANT NOTES:**

a) **Annexure-12 - QR DATA SHEET** is to be filled up properly for the stipulated QR parameters and to be submitted in the bid at appropriate file/folder provided for the purpose. The reference works whose details have been declared in Annexure-12 AND/OR in the submitted bid shall only be considered to ascertain the bidder's compliance to the specified qualifying Requirement (QR).

b) PROVISIONS FOR "AUTHENTICATION OF VERACITY OF DOCUMENTS SUBMITTED BY THE BIDDER IN SUPPORT OF QUALIFYING REQUIREMENT" AS INDICATED AT CLAUSE NO 26 OF ITB TO BE COMPLIED WITH. AUTHENTICATED DOCUMENTS (AS APPLICABLE-FROM INDEPENDENT STATUTORY AUDITOR OF BIDDER/ OR SPECIFIED THIRD-PARTY INSPECTION AGENCY (TPIA)) IN LINE WITH THE SAID PROVISIONS SHALL BE SUBMITTED.

b) **UDIN:** Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI). It is mandatory to mention UDIN (Unique Document Identification Number) by the bidders while submitting audited financial statements, other CA certificates etc. w.e.f. date as mentioned in ICAI gazette notification dt. 02.08.2019.
