a) Bidder should be an IRATA certified Rope Access Company (having valid membership

certificate from IRATA International & shall be listed on IRATA website)

#### AND

b) The Bidder should have successfully executed the work of structural/High Rise painting of High-Rise buildin or Structures during last seven (07) years as on the date of techno-Commercial bid opening (specified in ( ginal NIT) having minimum contract value as indicated below: -

i. One executed order of PO Value not less than Rs. 120.47 Lakh

ii. Two executed orders of PO Value not less than Rs. 75.29 Lakh each

#### 2.0 Financial Criteria

- **2.1** The average annual turnover of the bidder in the three preceding financial years, as on the date of ten no-Commercial bid opening (specified in Original NIT) shall not be less than Rs.150.58 Lakh.

They use techniques derived from climbing and caving to perform tasks : ch as maintenance, inspection, and construction on structures like buildings, bridges, and towers
- **b)** Word executed means the bidder should have achieved the criteria specified in the QR even if the con act has been started earlier and/or is not completed/closed and the same shall be supported by the dumentary evidence.
- c) In case of orders under execution, the value of work executed prior to the date of Techno- Commercia bid opening duly certified by bidder's client shall be considered
