### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

#### **1.0 Technical Criteria**

a) Bidder should be an IRATA certified Rope Access Company (having valid membership certificate from IRATA International & shall be listed on IRATA website)

AND

b) The Bidder should have successfully executed the work of structural/High Rise painting of High-Rise building or Structures during last seven (07) years as on the date of techno-Commercial bid opening (specified in Original NIT) having minimum contract value as indicated below: -

i. One executed order of PO Value not less than Rs. 120.47 Lakh

OR

ii. Two executed orders of PO Value not less than Rs. 75.29 Lakh each

OR

iii. Three executed orders of PO Value not less than Rs. 60.23 Lakh each

#### **2.0 Financial Criteria**

**2.1** The average annual turnover of the bidder in the three preceding financial years, as on the date of techno-Commercial bid opening (specified in Original NIT) shall not be less than Rs.150.58 Lakh.

**2.2** In case where audited results for the last preceding financial year as on the date of techno-commercial bid opening (specified in Original NIT) are not available, the financial results certified by a practicing chartered accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from

practicing chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial years shall be considered for evaluating the financial parameters. Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding document stating that the financial result of the company are under audit as on the date of Techno-Commercial bid opening and the certificate from the practicing Chartered Accountant certifying financial parameters is not available.

**Notes:-**

- a) A Rope Access Company specializes in providing safe and efficient access solutions for work at height or in difficult-to-reach areas. They use techniques derived from climbing and caving to perform tasks such as maintenance, inspection, and construction on structures like buildings, bridges, and towers
- b) Work executed means the bidder should have achieved the criteria specified in the QR even if the contract has been started earlier and/or is not completed/closed and the same shall be supported by the documentary evidence.
- c) In case of orders under execution, the value of work executed prior to the date of Techno- Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- d) Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.
- e) For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the breakup of basic value and taxes.
- f) Other income will not be considered in evaluation of turnover.

Requirement of PAN, GST Registration, valid PF code registration number, ESIC registration, T&P and equipment necessary for movement and installation of material (if applicable) are to be kept under general conditions of contract.
