1.0 QUALIFYING REQUIREMENT (QR)

1.1 TECHNICAL CRITERIA

1.1.1 The Bidder should have supplied at least one (1) number of DG sets of rating not less than 500 kVA, w hich should be in successful operation for at least one (1) year prior to the date of techno commercial bid opening. The offered make of the DG set (Alternator and Engine) against the current tender shall be same

as that of reference plant DG sets for which minimum **one-year successful operation is availa** ble as mentioned above.

1.1.2 The bidder should have executed contract for supply of DG sets of capacity 500 KVA or above as p er the following within the preceding seven (7) years prior to the date of techno-commercial bid opening:

A. Single Contract with executed value not less than Rs. 42 Lakhs

OR

B. Two Contracts with executed value not less than Rs. 26 Lakhs each

OR

C. Three Contracts with executed value not less than **Rs. 21 Lakhs each**

Notes for Technical Criteria:

- 1. The word "Executed" mentioned above means that the bidder should have achieved th e criteria specified above, even if the total contract is started earlier and/or is not compl eted / closed.
- 2. In case of orders under execution, the value of work executed prior to the date of Tech no-Commercial bid opening duly certified by bidder's client shall be considered accepta ble.
