1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. The order will be split among multiple bidders as per the criteria for splitting and Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

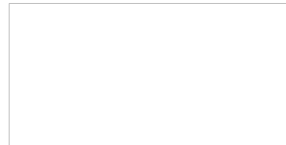

1. Additional Terms & Conditions (ATC) of this tender comprises the following documents:
 - a. Section-I: Invitation for Bids (IFB)/Tender Enquiry/Notice Inviting Tender (NIT).
 - b. Section-II: Instructions to Bidders (ITB)
 - c. Section-III: Bid Data Sheet (BDS)
 - d. Section-IV: General Conditions of Contract (GCC)
 - e. Section-V: Special Conditions of Contract (SCC)
 - f. Section-VI: Technical Specifications and Terms & Conditions

2. **Qualifying Requirements: Qualifying requirements shall be as per NIT.**

3. **EMD:** EMD is to be submitted in the form of Bank Guarantee/ Insurance Surety Bond **in the format specified in the Bid Document only.**

4. Eligibility for Participation: As mentioned in Sec-I NIT

5. "The format of the Bank Guarantee shall be in accordance with the form of Bank Guarantee towards Bid Security/EMD/Performance security included in the Employer's Bidding Documents only (refer Section-VIII: Forms and Procedures (Book 3 of 3)). In addition, the format of the Insurance Surety Bond shall also be in accordance with the form of Insurance Surety Bond towards Bid security/Performance security included in the Employer's Bidding Documents only (refer Section-VIII: Forms and Procedures (Book 3 of 3)). Any bid not accompanied by an acceptable bid security in a separate sealed envelope shall be rejected by the Employer as being non-responsive.
6. Bid Security: As per Sec-I NIT
7. MSEs seeking exemption for EMD and Purchase Preference shall select appropriate option on GeM portal (separately for each i.e. EMD & purchase preference) and should enclose attested/self-certified copy of UDYAM registration certificate, failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.
8. EMD exemption: Micro and Small Enterprises (MSEs) having UDYAM Registration, for goods produced and services rendered, shall be exempted from paying Earnest Money Deposit. Such registered bidder will have to submit UDYAM Registration Certificate, as a proof of being MSE on GeM Portal.
9. To avail MSE benefit in respect of EMD exemption and purchase preference, Bidder should be a manuf

acturer of offered product. Traders are excluded from purview of MSE benefit.

10. EMD exemptions as per GeM GTC shall be applicable.

11. Instructions for filling the Price Bid:

(1) The Bidder is required to quote **Lumpsum Price (Including GST)** in GeM Bid for all the BOQ items. Bidders are requested to kindly go through the Schedule of Quantities and Quote the entire package cost inclusive of GST.

(2) The Premium (%) or Discount (%) shall be derived considering total quoted amount Inclusive of GST with respect to NTPC's Estimate, Incl GST. This Premium (%) or Discount (%) shall be loaded on each items to calculate individual Item rates, Incl. GST

(3) The Break-Up of applicable GST is required to be quoted in Attachment-14 as per the provisions of the bidding documents.

(4) Bidders are requested to must check the total package cost against the estimated cost of NIT before submission of GEM Bid online to avoid any confusion later. After opening of technical Bids, Bidders are not allowed to modify/change the rates/amount whatsoever.

(5) Other terms and Conditions shall be as GCC & SCC of Civil.

15. Evaluation and Splitting criteria:

1. Bid Price: Bidder shall quote the price including GST for all the items against the Tender Price. Further, Bidders note that the Estimated Unit Rate for each line item (exclusive of GST) is displayed in price Bid schedule and accordingly Bidder has to offer their amount for entire package (inclusive of GST).

2. Each Bidder must submit Attachment-14 (Declaration regarding GST) being provided under the bid documents.

3. Splitting: Applicable.

4. MSE Benefit: Applicable.

17.0 Bidders are required to submit the duly filled mandatory **Proforma of Certificate -AA is to be enclosed along with Technical-commercial offer. Submission of “Proforma of Certificate -AA” is pre-requisite for price bid opening. Any bidder who will not furnish the aforesaid mentioned certificate, their technical bid will be rejected and will not be considered for price bid opening.**

18. **ABNORMALLY HIGH OR LOW RATED ITEMS**

If the rates/prices finalized with successful Bidder(s) are found to be having a variation of more than (-)10% in relation to Employer’s estimate of the cost of work to be performed under the contract, then such work shall be identified as “Abnormally Low Rate (ALR)”.

In such case, all the successful Bidder(s) shall be required to furnish an ‘Additional Bank Guarantee (BG)’ of an amount equal to 25% of the ‘Cumulative Differential Amount (against all ALR Items under the BOQ of the Bid)’, as illustrated below:

*All the Bidders who agrees to match the L-1 finalized rates will be required to furnish Additional Bank Guarantee (BG) as of an amount equal to 25% of the 'Cumulative Differential Amount as illustrated above.

This Additional BG shall be discharged after completion of the contract. However, Additional BG may be reduced on prorata basis upon successful execution of ALR Items on Three Monthly basis."

In case of splitting, Amount of Additional BG will be split among the successful bidders who agreed to match the L-1.

18. Scanned copy of the EMD BG shall be uploaded by Seller in the online bid and hard copy of the same will have to be submitted directly to the Buyer within 5 working days of bid opening, failing which the bid may be treated as incomplete & may lead to rejection of the bid by buyer without making any reference to the seller. Bidders are requested to refer details regarding the same in BDS clause 10 of tender documents.

All the terms & conditions shall be as per NTPC mentioned in ATC. If any contradiction arises between ATC and GeM terms & conditions, Terms & conditions mentioned in ATC shall prevail.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
