1.1 TECHNICAL CRITERIA

1.1.1 **Bidder should be a manufacturer** of 'Dozer and or its spares'.

1.1.2 Bidder should have executed order(s) for supply of new Transmission Assembly for 'Do zer/Bulldozer' BD-155 / BD-355.

1.1.3 Bidder should have executed order(s) for Supply of spares of 'Dozer/Bulldozer' within preceding seven (07) years prior to the date of techno-commercial bid opening in any of the following manner:

A. One (1) order having executed value not less than Rs. 128 Lakhs

OR

- B. Two (2) orders having executed value not less than Rs. 80 Lakh each OR
- C. Three (3) orders having executed value not less than $\ensuremath{\text{Rs. 64}}$ Lakh each

Notes for Technical Criteria:

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's cli ent shall be considered acceptable.
- 3. For arriving at the executed value of work specified above, basic amou nt only shall be considered. In case contract is inclusive of taxes, bidder should provide the break – up of basic value and taxes.

1.2 Financial Criteria:

1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 161 Lakh (Rupees One Crore & Sixty One Lakhs only)** during the prec eding three (3) completed financial years as on the date of Techno-Commercial bid opening.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding fina ncial year is at least equal to or more than the paid-up share capital of the Holding Company.
