1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 4. **Qualifying Requirements for Bidders**:

4.1 **Technical Criteria:**

Notes for Technical Criteria:

 The word "Executed" mentioned above means that the bidder should have achieved t he criteria specified above, even if the total contract is started earlier and/or is not com pleted / closed.

 In case of orders under execution, the value of work executed prior to the date of Tec hno-Commercial bid opening duly certified by bidder's client shall be considered accept able.

 For arriving at the executed value of work specified above, basic amount only shall b e considered. In case of contract is inclusive of taxes, bidder should provide the break – up of basic value and taxes.

 Latest annual report OR NSIC / SSI / MSME registration certificate / BIS license / ISO ce rtificate /MDCC/ any other statutory document as a proof of being manufacturer as per QR.

4.2 Financial Criteria:

- 4.2.1 The Average Annual Turnover of the Bidder, should not be less than Rs. 113 Lakh (Rup ees One Crore Thirteen lakh only) during the preceding three (3) completed financial years prior to the date of Techno-Commercial bid opening.
- 4.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 4.2.1 above on it s own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 4.2.1 above, provided that the net worth of such Holding Company as on the las t day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish al ong with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 4.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone e ntity basis, the unaudited unconsolidated financial statements of the bidder can be consid ered acceptable provided the bidder further furnishes the following documents for substa ntiation of its qualification:

Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.

A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statem ents form part of the Consolidated Annual Report of the company.

4.2.4 In cases where audited results for the last preceding financial year as on the date of tech no commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial y ear shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno company.

- "Holding Company" and "Subsidiary Company" shall have the meaning ascr ibed to them as per Companies Act of India, in vogue.
- 3. Net worth means the sum total of the paid-up share capital and free reserves. F ree reserve means all reserves credited out of the profits and share premium acco unt but does not include reserves credited out of the revaluation of the assets, wri te back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- 5. Notwithstanding anything stated above, the Employer reserves the right to assess the ca pabilities and capacity of the Bidder/ his collaborators /associates/ subsidiaries / group co mpanies to perform the contract, should the circumstances warrant such assessment in t he overall interest of the Employer. The physical assessment shall include but not be limit ed to the assessment of office/facilities/banker's/reference workers by Employer. A negati ve determination of such assessment of capacity and capabilities may result in rejection of the bid.
