**1.** Bidder should submit the Technical Compliance sheet along with detailed datasheet/ Product catalogue/ brochure of the offered product.

**2.** The Techno-Commercial Bid should not contain any price content entry. In case, the Techno-Commercial Bid is found to contain any price content, such bid shall be outrightly rejected.

**3. CPG :** The Contractor shall be required to furnish the Contract Performance Guarantee (CPG) for an amount equal to 5% of total order value.

CPG should be valid for a period of three months (3 months) beyond the expiry of warranty period. The CPG should be submitted within 30 days of placement of award.

**4. Delivery Period:** 15 days from placement of award.

**5. PAYMENT TERMS:** 100% payment shall be released after successful installation of material.

**6. OEM Authorization :** This Bid is reserved for Authorized partner of M/s LG Electronics India Pvt (OEM). Any Bid received without valid authorization from said OEM shall be outrightly rejected.
