3.0 All bids must be accompanied by Earnest Money Deposit for an amount calculated at the rate of **INR 16.38 Lakh per MW** (Indian Rupees Sixteen Lakh Thirty Eight Thousand per MW) and in the form as stipulated in the RfS Documents
