Part 1: General Information

General Details about NTPC SIPAT:

BRIEF

NTPC Sipat, a prestigious thermal power station with (2980 MW Installed +800MW under Construction) capacity has been transporting ash to various work sites within the guidelines provided in the gazette notification dated 31.12.2021 published by MOEF&CC.

To conserve environment, NTPC Sipat intends to use Electric Vehicles also in ash transportation works.

In this pursuance, Expression of Interest is invited from GST registered agencies with sound financial background who wishes to participate in ash transportation works using ELECTRIC VEHICLES (EVs).

SCOPE OF WORK:

1. Electrical Vehicles (EVs) are to be deployed at NTPC Sipat for ash transportation works for short as well as long distances.
2. Short routes shall be:
 - a. NTPC SIPAT Ash Silos to Ash Brick plant (for transporting DFA in bulkers)
 - b. Bottom Ash transportation from Dyke to Ash Brick Plant
 - c. Cement bag transportation from Store to Ash brick Plant
 - d. Various sites within 60 Km distance from NTPC Sipat.
- 3 Long routes shall be NHAI/PWD road sites with maximum transportation distance approximately up to 300-350 Km as per location of road construction sites.
- 4 The agency shall also arrange the loading equipment for the EVs provided by them.
- 5 Transportation of ash shall be done with fully covering of vehicles using 200 GSM Tarpaulin sheets. The transporting vehicle shall follow the SOP for ash transportation encompassing loading, covering, fugitive emission control during transportation and other relevant aspects of ash transportation.
- 6 Compliances to all relevant and applicable statutory conditions provided in Motor vehicle Act, Environmental Act, Workmen Compensation Acts etc. shall be in the scope of the agency.
- 7 The agency shall ensure the payment of minimum wage, insurance, retrenchment, bonus and all other statutory benefits as per applicability.
- 8 All periodic maintenance, breakdowns, vehicle upgrades shall be looked after by the agency
- 9 Facilities for charging of the vehicle shall be arranged by the agency.
- 10 Payment shall be based on (a) Quantity of material excavated/loaded in Cum/MT and (b) distance travelled in Km.
- 11 All payments shall be done under online mode. NTPC shall reimburse/pay the required GST/any other tax applicable.
- 12 Detailed terms and conditions of the operations shall be finalized after due discussion with the agencies submitting EOI.
