OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. 1. NTPC invites on-line bids on Single Stage Two Envelope Bidding basis (Envelope-I: Tec hno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders for aforesaid package , as per the scope briefly mentioned hereinafter.

2. Brief Scope of Work

The scope under this contract includes:

Supply of Microprocessor based PC controlled carbon-Sulphur analyzer for analysis of sulphur and total carbon in coal. Dual Range Sulphur determinator must be latest based on High-Temperature Tube Combustion with Infrared Absorption as per ASTM D-4239-18 method A or Method B. Instrument must use infrared cells and detectors for Sulphur as well as carbon (Total Carbon) analysis. Thus, it should contain both Sulphur IR cell and carbon IR cell. Should have range selection or auto-selection capabilities.

The detailed scope and description covered under this package has been specified in the relevant clause of Detailed Technical Specification/Technical Data Sheet.

NTPC intends to finance subject Package through Domestic Commercial Borrowings/Ow n sources.

4. Qualifying Requirements for Bidders:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

4.1 Technical Criteria:

4.1.1 **(a)** The bidder should be a manufacturer of coal analysis equipment such as bomb callorimeter and/or thermogravimetric analyser and/or carbon-sulphur analyser.

OR

- **(b)** An authorized dealer / distributor / channel partner / Indian representative of the m anufacturer of coal analysis equipment as described at 4.1.1 a) above. Authorized repre sentative should be specifically authorized by the manufacturer to participate in this bid.
- 4.1.2 The quoted make of Carbon-Sulphur Analyser must have been supplied to either pow er plants/ PSUs/government Organizations or CSIR laboratories, universities, Research la boratories during the last 5 years period and must be performing satisfactorily for mini mum 1 year in service after its installation & commissioning. The cut-off date for this purpose shall be the actual BOD of this tender.
- 4.1.3 The bidder should have executed purchase orders for supply of coal analysis equipme nt as described at 4.1.1 a) above with carbon-sulphur analyser as one of the items within preceding seven (07) years Prior to the date of Techno-commercial bid opening as per any of the following criteria:
 - 1) One (1) order having executed value not less than Rs.57.00 Lakh.

OR

2) Two (2) orders having executed value not less than Rs 36.00 Lakh each.

OR

3) Three (3) orders having executed value not less than Rs 28.00 Lakh each.

Notes for 4.1:

Note-1: The word "executed" means the bidder should have achieved the criterion spec ified in the QR, even if the total order(s) is not completed/closed. In case of order(s) und er execution as on the date of techno commercial bid opening, the value of work execut ed till such date will be considered provided the employer certifies the same.

Note-2: For the purpose of arriving at the executed value of work, basic amount only shall be considered. In case of order(s) inclusive of taxes, agency has to provide the break –up of basic value and taxes.

4.2 Financial Criteria:

- 4.2.1 Average annual Turnover of the bidder in the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening, shall not be less than Rs 71.00 Lakh s (Rupees seventy-One lakhs only).
- 4.2.2 In case a bidder does not satisfy the financial criteria, stipulated at Cl. 4.2.1 above on its

own, its Holding Company would be required to meet the stipulated turnover requirement s at Cl. 4.2.1 above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share cap ital of the Holding Company. In such an event, the Bidder would be requested to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the Bid Documents, pledging unconditional & irrevocable financial support for the execution of the Contract by the Bidder in case of award.

- 4.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone e ntity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:
 - Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.
 - A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statem ents form part of the Consolidated Annual Report of the company.
- 4.2.4 In cases where audited results for the last preceding financial year as on the date of tech no commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno commercial bid opening and the Certificate from the practicing Chartered Accountant certificate financial parameters is not available.

- 1. "Holding Company" and "Subsidiary Company" shall have the meaning ascr ibed to them as per Companies Act of India, in vogue.
- 2. Other income shall not be considered for arriving at annual turnover.
- 3. **Net worth means** the sum total of the paid-up share capital and free reserves. F ree reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- 5. Notwithstanding anything stated above, the Employer reserves the right to assess the ca pabilities and capacity of the Bidder/ his collaborators /associates/ subsidiaries / group co mpanies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is also governed by the General Terms and Conditions/ यह बिड सामान्य शर्तों के अंतर्गत भी शासित है

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
