- 1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirement s stipulated hereunder:

1.1: Technical Criteria:

1.1.1 The bidder should be a "manufacturer" or "Authorized Dealer of the manufacturer of air conditioner.

AND

1.1.2 The bidder should have executed supply of air conditioner/HVAC package in the pr eceding seven (07) years prior to Techno-commercial bid opening date, meeting the following criteria

i) Single order of executed value not less than Rs. 83 Lakhs.

OR

ii) Two orders of executed value not less than Rs. 52 Lakhs in each order

OR

iii) Three orders of executed value not less than Rs. 42 Lakhs in each order.

Notes for Technical Criteria:

- 1. The word "Executed" mentioned above means that the bidder should have achiev ed the criteria specified above, even if the total order is started earlier and/or is n ot completed/closed.
- 2. In case of orders under execution, the value of the order executed prior to the dat e of Techno-Commercial bid opening duly certified by bidder's client shall be cons idered acceptable.
- 3. For arriving at the executed value of the order specified above, basic amount only shall be considered. In case order is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 4. The bidder must submit Latest annual report OR NSIC / SSI / MSME registration cert ificate / BIS license / ISO certificate / any other statutory document as a proof of b eing manufacturer as per QR.
- 5. In case HVAC package PO is submitted in support of QR clause 1.1.2, total packag e value shall be considered.

1.2: Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs.104Lakhs** (**Rupees One Hundred & Four Lakh only**) during the preceding three (3) completed fina ncial years as on the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover require ments at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the I ast day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging

unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

- 1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alo ne entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
- -Copies of the unaudited unconsolidated financial statements of the bidder along with copi es of the Audited consolidated financial statements of its Holding Company.
- -A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form p art of the Consolidated Annual Report of the company.
- 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- 3. Net worth means the sum total of the paid up share capital and free reserves. Free r eserve means all reserves credited out of the profits and share premium account but d oes not include reserves credited out of the revaluation of the assets, write back of dep reciation provision and amalgamation. Further, any debit balance of Profit and Loss acc ount and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
